CALL TO ORDER

Chair Sharon Taylor called the meeting to order at 5:38 p.m.

PUBLIC COMMENTS

There was no one present who wished to comment.

APPROVAL OF MINUTES

Michael Lacadie moved to approve the September 20, 2017 meeting minutes as written. The motion was seconded by Laurie Maus. Voice vote was taken and the motion passed unanimously.

DeeAnn Harris moved to approve the October 5, 2017 public hearing minutes as written. The motion was seconded by Mumbi Ngari-Turner. Voice vote was taken and the motion passed unanimously.

REVIEW OF OCTOBER 5, 2017 PUBLIC HEARING

The public hearing testimony was discussed.

ADOPTION OF FY2018 CDBG & HOME POLICIES

Jeff Gumm reviewed the Draft FY2018 CDBG /HOME Policy document. He noted that the City Council has not proposed any changes for the coming year. Discussion ensued.

Laurie Maus moved to approve the Draft FY2018 CDBG /HOME policies as presented. The motion was seconded by Michael Lacadie. Voice vote was taken and the motion passed unanimously.

PREPARATION OF 2017-2018 HUMAN SERVICES FUNDING RECOMMENDATIONS

The CSAB committee reviewed third quarter reports submitted by organizations currently receiving human services funds. Each organization provided a narrative report on program performance, as well as highlighting any agency issues and examples of program successes and service impacts.

CSAB members also reviewed service data including number of clients served; grant expenditures, and service goals to determine if programs will meet their annual contracted goals.

Criteria for 2nd year funding recommendations were discussed. It was determined that programs, which are meeting service goals and fully funded at \$25,000 would be recommended to receive full funding again in 2018. Other 2nd year funding recommendation criteria would include:

- 1. The program's on-target performance and its ability to expend all grant funds by the end of the year.
- 2. The program's ability to recoup service levels even if it experienced staff turnover or other organizational changes that affect current service levels (loss funding or policy shifts).
- 3. The organization's previous and current track record of compliance with all contracting requirements.

The CSAB then discussed how to allocate undesignated funds (approximately \$10,000). These funds would be used to increase grants to only 2017 funded programs. The Board then identified programs that may be recommended for increased funding based on superior program performance and demonstrated ability to reach underserved populations.

The CSAB will finalize its 2nd year funding recommendations at next week's meeting on Wednesday, October 18, 2017.
