Run down of the project: The Eagle Scout Project mainly consists of stabilizing the fence that runs around the park. The method for fixing the problem with the fence is by digging about 10 inches all around the post (that is leaning) then pour concrete mix into the hole, add water then mix it up, and when it dries the fence post will be stable. There are approximately 40 posts that need to be done. Also there are do not enter signs that need to be put up on 2 different gates. Also there is an obstacle in the obstacle course that is getting run down and needs to be sanded and repainted, and in another obstacle some rocks have been dropped into the supports so we will vacuum them out. The safety hazards we might faces are splinters, hand injury from bar, and blisters. The best way to prevent all of these hazards is to use working gloves.
