

SUBJECT:	Legacy Plan Update

PURPOSE: The purpose of this memorandum is to provide an overview of the forthcoming update to the City of Lakewood's city wide parks and recreation master plan, known as the Legacy Plan (hereinafter, the "Plan"). In effort to craft an update that reflects the needs and desires of the community, the City endeavors to make this process community-driven. To do so, the City will encourage and enable community participation throughout the process by offering a diversity of options for community members to provide input and feedback.

BACKGROUND: After three years of work with various community groups and stakeholders, the City of Lakewood approved the current Plan in March 2014. Since its approval, the Plan has served as the strategic plan for building a healthy and sustainable parks and recreation system in Lakewood. The Plan has contributed to various policies and procedures, been instrumental in the development of various parks and recreation programs and services, supported successful grant awards and capital improvement projects, and as a foundation for the City budget process. For the Plan to remain timely, as well as competitive for grant funding, the Plan requires periodic updates. For the City to remain grant eligible for Washington Recreation and Conversation Office (RCO) grants, the Plan must be updated every six years. To meet this requirement, the City intends to update the Plan by 2020. This meeting serves to kick off this process.

The forthcoming update to the Legacy Plan will overview accomplishments of the past few years, inventory and evaluate existing parks, recreation areas, and programming, as well as assess the need for improvements (site, facility, and operations), prioritize and review potential expansions and acquisitions, and reevaluate the Plan's current goals and policies to ensure that they are align with the community's values, needs, and desires.

The following provides a general list of potential updates to the Plan. This list is not intended to be exhaustive. The City acknowledges that community input and further research will continue to inform the update process.

Community Profile. The updated Plan will include up-to-date data on the following elements in Lakewood:

- Location;
- History;
- Natural setting;
- Demographics, including population, race and ethnicity, household characteristics, income and poverty, employment and education, and persons with disabilities;
- Economy
- Benefits of parks and recreation;
- List of accomplishments since 2014;
- Plan overview;
- Plan structure;
- National and Regional trends;
- Local trends and community feedback;
- Goals, strategies, performance measures;
- Level of service;
- And more!

Goals and Objectives. Throughout this process, the City will review and update the ten goals and over 120 strategies listed in the current Plan to ensure that they are relevant, realistic, and supported by resources.

Classifications / Inventory. The City will conduct a new inventory of existing facilities and programs and compare this inventory to the inventory found in the current Legacy Plan. This comparison will include a summary of the accomplishments and service gaps. The inventory, in addition to community and focus group feedback, will help prioritize projects throughout the rest of the update process. City personnel will conduct physical inventories of parks, facilities, trails, and programming, as well as use City documents, such as capital improvement plans and maintenance records.

Public Involvement. Like the existing Plan, the updated Plan would continue to act as a strategic roadmap for building a healthy and sustainable parks and recreation system in Lakewood. For the City, an imperative step in this process will be engaging the community to ensure that the updated Plan reflects the current needs and desires of those that live, work, and play in Lakewood.

In June 2018, the City adopted its Strategic Plan 2018 to 2020. Under the City Council goal area of Transparency, the City adopted the following strategy:

"5.4 Strengthen connection with stakeholders, partners, and communities.

B. Focus on inclusive engagement: Conduct concentrated outreach for hard-to-reach and vulnerable populations."

Goal Nine (9) of the current Plan states:

"Goal 9: Maintain and update the Legacy Plan goals, strategies, policies, and procedure in response to changing needs, trends, performance outcomes, and statutory requirements.

9.1 Maintain plan update cycle to ensure plan relevancy."

Goal Ten (10): of the current Plan states:

"Goal 10: Make accountable, transparent, and responsible decisions by considering the environmental, economic, social and cultural impacts to our community.

10.4 Demonstrate accountability and transparency in decision-making processes."

The City is committed to performing extensive public outreach throughout this process. In effort to maximize outreach opportunities to engage community members, the City is planning on facilitating a diversity of engagement opportunities, such as the following:

- 1. Legacy Plan Task Force. The Legacy Plan Task Force (LPTF) would consist of City personnel, local stakeholders, partners, and community members. The LPTF would meet regularly to provide guidance on the Plan update process. LPTF members would be asked to read meeting briefs, review planning documents, address questions, help with community outreach, and assist the City in making decisions on Plan update developments. Meetings are anticipated to be held once a month, lasting around two (2) hours.
- 2. **Surveys.** In effort to provide flexible opportunities for those who live, work, and play in Lakewood, the City may use online and mail surveys. The surveys would allow users to provide feedback on: 1) current parks and recreation options and service levels, 2) use of facilities, programs, and service levels, and 3) parks and recreation needs.

<u>Online survey.</u> Participants would be able to access the survey online via the City's Website, social media outlets, Connections Magazine, the City Manager's Bulletin, and an email blast to registered park recreation participants. A draft survey can be found here: <u>https://www.surveymonkey.com/r/LakewoodParks</u>. While this survey would not be statistically valid, it would still provide good information for the City to use in this process.

<u>Statistically valid survey (mail/online).</u> Participants would be chosen at random to participate in a mailed survey and/or an online survey. These surveys would be statistically valid. **Attachment A** provides a draft of the mail survey. The online survey would be similar to the draft mail survey. Participants would receive a letter with the link to the online survey included.

3. **Open House Meetings.** The City will likely facilitate in-person meetings at City Hall and other City facilities. These meetings would provide opportunities for those who live, work, and play in Lakewood to provide in-person comments and feedback about parks and the recreation needs and opportunities in Lakewood.

At the meetings, participants would have the opportunity to make comments on existing parks and recreation facilities, arts and culture, conservation and open space, and trails.

4. **Online Public Form**. To provide an alternative way for people to provide feedback, the City is considering creating an online public forum. The forum would be designed to mimic the experience provided at the in-person meetings.

- 5. Focus Groups / Targeted Outreach: The City will likely provide targeted outreach to neighborhood groups, stakeholder, City personnel, and community "pop-up" events. The following provides a draft list of potential focus group / targeted outreach events:
 - a. City Council.
 - b. Neighborhood Associations.
 - c. Recreation Program Groups
 - d. Sport Groups
 - e. Environmental Groups
 - f. City Personnel Meetings
 - g. Community "Pop-up Events" e.g., SummerFest, Farmer's Market, Senior Center Open House, etc.

Demand and Need Analysis. The update will include the performance of a new demand and need analysis. Among other things, this analysis will likely include research into the following areas:

- National and Regional trends
- Local trends and community feedback
 - Community survey findings
 - Feedback from Open Houses, Focus Groups
 - Park and Facility condition assessment matrix
- Recreation projects:
 - Current levels of participation
 - Anticipated change based on trends
 - Capacity of your current inventory
 - Distance between residential areas and existing opportunities
 - Public satisfaction
 - Manager needs
 - Current maintenance levels
 - Access issues
- Habitat projects:
 - Number and extend of species present
 - Known threats
 - Condition of available habitat
 - Opportunities for habitat restoration / improvement
 - Public Support
 - Management needs
 - Stewardship levels
 - Potential for compatible public access
- Park classification:
 - Distribution / Proximity
 - Development / Improvements
 - Acquisition
 - Management / Maintenance
- Gap analysis / Level of Service Assessment

Capital Improvement Plan. The updated plan will include the most recent capital improvement plan. Future capital improvement plans will be guided by the update. The updated plan will likely include a prioritized list of recommended capital improvement projects for the short term, as well as for the long term.

Update Timeline. Table A provides a general timeline for the Plan update.

Public Comments:

GENERAL PARK ISSUES AND COMMENTS:

- Parking is #1 issue
- Parking Hours sign needed & enforcement
- Parking on Cherry and other roads
- Security/Privacy Issues-homeless/trespassing
- More enforcement/signage
- Signs get removed
- Stump with rebar in lake-scary needs to be cut
- People ignore signs
- Build more bulkheads to expand park into water
- Boat launch moved in a way to not impede traffic-blocks Edgewater/ Foster
- Have we done a survey of how people would like to use the site?
- Could public boat launch be on a street end- No public street ends (may have been vacated by Pierce County) End of 100th used to be a boat launch. Would need to do a study to find out if there were other access points
- Propose to buy the apartments and use that area for parking lot and to extend park
- Boat Launch relocated closer to Sacramento St
- Need to post sign: cannot exceed 8 mph in the cove. Cannot jet-ski from the launch.
- Public works traffic studies in March/April vs July
- Add speed humps (humps are better that bumps for boat trailers)
- Would like no parking
- Small area of land-overcrowding can be an issue- how will it be mitigated
- Many neighbors only access to their homes is the alley
- Homes closer to the park have more issues
- City of Lakewood residents pays taxes to have shoreline access. Many people don't have the privilege of living on the lake.

<u>Like</u>:

- Small Lights and more of them
- One way "South"
- Parking and sidewalk buffer
- Picnic Area with heavy tables/chained down
- Grass area
- Small dock
- Swim Area w/buoys for safety
- Garbage & Recycle
