Civil Service Rule Revision

Housekeeping changes included a change to the rule citation in rule 4.33 Non-commissioned, from 4.15 to 4.18. The cover page was revised to include the rule changes adopted on September 7, 2017 and today's proposed revision will also be added.

It was moved and seconded to approve the rule change and revisions to the cover page. The motion carried unanimously.

Chief Examiner's Report

- Officer Sean Conlon promoted to Detective.
- Two candidates on the Entry Police Officer eligibility list withdrew from consideration.
- Oral board interviews for Lateral Police Officer will be scheduled on July 12th and 16th. There are nine Washington residents among the pool of 15 candidates.
- Oral board interviews for Entry Police Officer will be scheduled for June 18th.
- There will not be an August 2nd Civil Service Commission meeting due to the Secretary-Chief Examiner's vacation.
- Jamin Dobson was reinstated on the Lateral Police Officer eligibility list.
- Commissioner Roden noted an error in the May 3rd minutes. The first bullet included in the Chief Examiner's Report should refer to Court Compliance Officer not Community Service Officer. The minutes will be corrected following this meeting.
- Commissioner Roden asked how long the recordings of Commission meeting are kept. According to the City Clerk, recordings are kept for 6 years after final disposition then transferred to the state archives for appraisal and selective retention.
- Kymm Cox responded to Commissioner Roden's question regarding the City paying lodging expenses for out of state Police Officer candidates. Her cursory check found there is no prohibition but there are some concerns, i.e. if this is done for police officer candidates then why not for other candidates. Typically, the practice has been that this is only considered for higher level positions. Practically speaking, the City is not willing to go in this direction at this time.
