INTERLOCAL AGREEMENT EMERGENCY MANAGEMENT SERVICES ADDENDUM 6-2019

THIS AGREEMENT is made and entered into by and between the City of Lakewood, incorporated under the laws of the State of Washington (hereinafter referred to as the "City") and West Pierce Fire & Rescue, a municipal corporation of the State of Washington (hereinafter referred to as the "WPFR").

WITNESSETH:

WHEREAS the City and WPFR currently have an Interlocal Agreement in place for Emergency Management Services; and,

WHEREAS, the ILA defines payment parameters in Section 7; and,

WHEREAS, per section 7.b of the ILA should EMGP grant funding be diminished and/or eliminated the parties agreed to determine if the program should continue and/or be altered by mutual agreement of the parties; and,

WHEREAS, the parties have met and determined the program shall continue with the following payment modifications;

- 1. WPFR and the City agree to share the reduction in EMPG grant funds equally.
- 2. The City shall utilize EMPG grant funds of \$33,265 along with their share of the reduction as defined above in item 1 to fund the ILA with WPFR from September 1, 2018 to August 31, 2019.
- 3. All other terms of the ILA shall remain unchanged.

IN WITNESS THEREOF, the parties acting in their official capacities have hereby executed this Agreement by affixing thereto the signatures of the proper officers on the date indicated.
