CALL TO ORDER

Mayor Anderson called the meeting to order at 7:00 p.m.

ROLL CALL

<u>Councilmembers Present</u>: 7 – Mayor Don Anderson; Deputy Mayor Jason Whalen; Councilmembers Mary Moss, Mike Brandstetter, John Simpson, Marie Barth and Paul Bocchi.

ITEMS FOR DISCUSSION:

Review of 3rd Quarter Financial Report.

Assistant City Manager for Administrative Services Kraus provided an overview of activity in all funds through September 30, 2019. Discussion ensued.

Review of public nuisance code amendments.

Senior Policy Analyst Kelley-Fong shared that as a follow up from her June 24th presentation related to illegal dumping it is recommended that the City Council adopt code amendments addressing abandoned shopping carts. She shared that the intent is to reduce the lost, stolen or abandoned shopping carts throughout the city. She reported that she visited several retail stores within the city to review and discuss the proposed legislation. An Ordinance will come forward for approval at the December 16th City Council meeting. Discussion ensued.

Review of cooperative use agreement with Clover Park School District.

Parks, Recreation and Community Services Director Dodsworth shared that a stakeholders group with representatives from the City and Clover Park School District (CPSD) met from April through June, 2019 to discuss and prepare a cooperative use agreement for City and CPSD facilities. She highlighted areas of the draft agreement and shared that the City Council and CPSD Board will review the agreement at a future joint meeting. Discussion ensued.

Special Events Update.

Recreation Coordinator Martinez provided an overview of 2019 special events coordinated by the Parks and Recreation Department. She highlighted events that are scheduled for 2020.

City Manager Caulfield reported recognized city employees for their work coordinating several events and activities in support of the community over the past several weeks.

He shared that the Defense Community Infrastructure Program (DCIP) has been qualified and is expected to be funded at \$50 Million.

He then shared that the National Cyclocross Championship held last week at Fort Steilacoom Park was a success and he complimented City Departments for their collaborative effort in organizing and facilitating the event. Travel Tacoma & Pierce County will be completing an economic analysis which will show the impact to the area.

He reported that the City was contacted by a realtor working with Stockman Properties as the owners are interested in selling two parcels on Military Road that border Washington Park. The Stockman's have asked if the City has any desire in purchasing the properties.

He shared that the Assistant City Manager for Community and Economic Development is working on updates to the Multi-Family Property Tax Exemption (MFTE) Program which will be brought forward in 2020 for City Council review.

He recommended the Council consider incorporating the Martin Luther King Jr. Committee as part of the Arts Commission since the City provides funding and staff resources to assist with the event.

He shared that the Human Resources Director McDougal has elected to the Washington Public Employer Labor Relations Association (WAPELRA) Board for a 3-year term and Public Works Engineering Department will be advertising several road projects in early 2020.

<u>RECOMMENDATION</u>: That the City Council pass a motion authorizing the City Manager to approve a contract with the WA Department of Commerce accepting \$100,000 in grant funds for the Lakewood Station District Subarea Plan, Planned Action and Hybrid Form-Based Code (LSDS.)

<u>DISCUSSION</u>: Pursuant to E2SB 1923, The City of Lakewood has been awarded \$100,000 in grant funds to create a subarea plan, SEPA planned action and a hybrid form-based code for the Lakewood Station District. The award letter from Commerce and the proposed contract is attached hereto.

Lakewood has recognized the need for, and memorialized initial design for, a subarea plan in the Lakeview Neighborhood / Lakewood Station District since adopting its first Comprehensive Plan in 2000; in fact, the Plan's Land Use Policy 25.5 and Urban Design Policy 9.5 both direct the preparation of a sub-area plan for the Lakewood Station District, and a preliminary design vision for the subarea was created (see map above.) In 2012, Sounder Train service was extended to the Lakewood Station, located along Pacific Highway South near I-5.

The Comprehenive Plan defines the Lakewood Station District as a "transit-oriented neighborhood with higher density residential uses, medically oriented businesses, and other commercial uses responding to increase transportation access in the area." Discussion is continued below.

<u>ALTERNATIVE(S)</u>: The City Council could approve this motion; the Council could also amend or reject this motion.

<u>FISCAL IMPACT</u>: The contract for \$100,000 would reimburse the City for hiring a consultant to coordinate the LSDS development with CEDD staff. No matching funds are required from Lakewood; staff in-kind services will serve as the match for the grant.

City Manager Review:

DISCUSSION CONTINUED:

Over time, and in addition to the Comprehensive Plan policies mentioned above, the City has continued to prioritize the Lakewood Station District as an important area for economic development, housing diversification, and transportation demand management. Lakewood's Comprehensive Plan has a number of goals, objectives and policies related to the Lakewood Station District, and the City's 2018-2020 Strategic Plan prioritizes affordable and mixed income housing, maximizing public transit, and public involvement in land use planning.

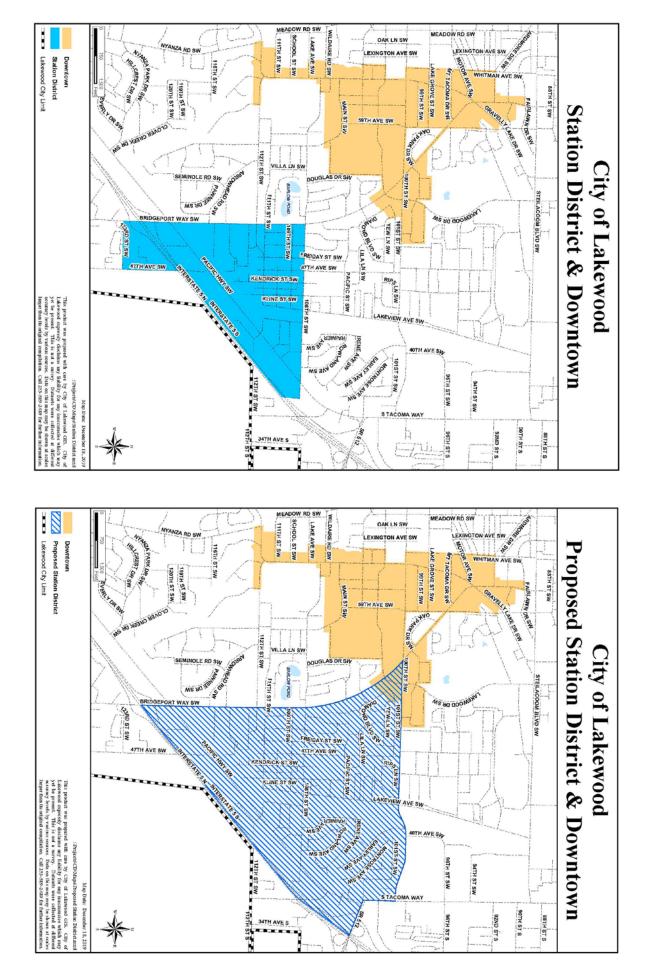
In November, 2019, the State Department of Commerce awarded the City of Lakewood, WA a grant under ESB 1923 to: prepare a subarea plan for the Lakewood Station District per RCW 43.21C.420; prepare a planned action per RCW 43.21C.440 (1)(b)(ii); and prepare a hybrid form-based code to implement the Lakewood Station District Subarea Plan.

The timeline for this effort anticipates completion by mid-2021.

When the 2000 Lakewood Station District subarea (LSDS) boundaries as identified within the Comprehensive Plan at Section 4.5.2 are amended to extend north to 100th St SW, east to the SR 512 interchange, south to I-5, and west to Bridgeport Way, the subarea has several existing low-income neighborhoods ready for redevelopment at higher densities along a high capacity transit corridor and within ½ mile of the Lakewood Station.

A subarea plan incorporating residential densification would: maximize access to public transit; provide housing affordable to the City's current residents; help prevent current resident displacement as well as provide additional mixed income housing units for future targeted growth; and serve as an excellent complementary planning area to the Downtown. The Lakewood District also does not have the same environmental and infrastructure constraints (i.e., lakes and associated wetlands, and existing road widths and routes) as much of the western area of the City that makes residential redevelopment at higher densities unlikely there. As a result, higher residential densities are more practically feasible in the Lakewood Station District than in western Lakewood.

The two maps below show the current and currently proposed boundaries for the Lakewood Station District subarea. The Council is requested to provide direction regarding the boundaries of the subarea before the City begins its work on the project.



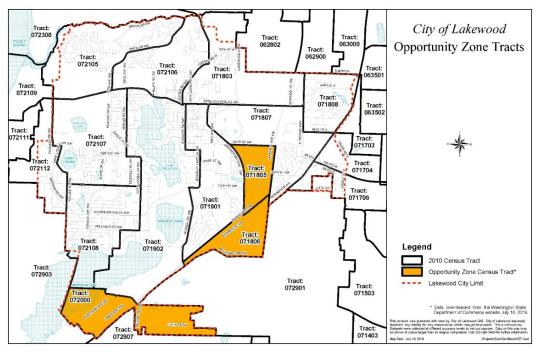
PLANNING FOR POPULATION GROWTH IN LAKEWOOD:

The residential zones within the proposed amended Lakewood Station District subarea boundaries currently include approximately: 255 acres of Residential 3 (R3); 16 acres of Residential 4 (R4); 90 acres of Mixed Residential 1 (MR1); 50 acres of Multi-Family 1 (MF1); and 60 acres of Multi-Family 3 (MF3.) Based on a 2019 citywide analysis of residential development, these zones are not built out to maximum capacity:

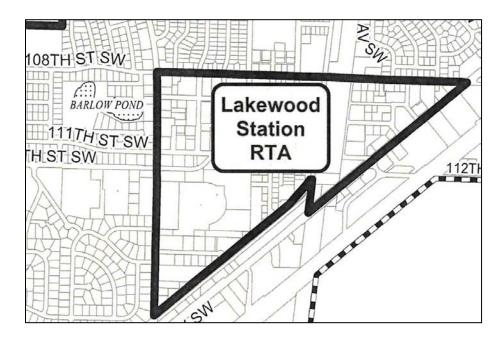

Focusing redevelopment and densification efforts in the subarea could, even without rezoning properties, therefore result in an estimated additional 3,514 units: 380 units in the R3 zone; 32 units in the R4 zone; 355 units in the MR1 zone; 537 units in the MF1 zone; and 2210 units in the MF 3 zone. If areas were partially or fully rezoned to R4, MR2 and MF3 (which would be subject to legislative action), significantly more units could be achieved within the subarea. The 3,514 units would comprise almost 31% of the 11,462 new units Lakewood is planning for by 2030.

Two existing economic tools coincide with and would buoy the benefits of developing a Lakewood Station District Subarea Plan (LSDS.) The LSDS boundaries overlap with the federally established Lakeview/Kendrick Street Opportunity Zone (Tract 071805):



In addition, Lakewood has established areas where Multi-Family Tax Exemptions are available, including the Lakewood Station residential target area (RTA):



STREAMLINE REGULATIONS:

The Lakewood District Subarea Plan (LSDS) Planned Action would eliminate SEPA review for projects within the LSDS boundaries. The estimated time and cost savings via a Planned action include:

- Avoided delays
 - DNS up to 90 days
 - EIS up to12 months
- Avoided costly process and technical studies for applicants, e.g. transportation modeling
 - Consultant cost for a DNS/Checklist varies depending on technical reports required. DNS/Checklist ~\$10,000 plus \$15,000-25,000 for standard transportation report, plus more for other topics.
 - Consultant cost for an EIS is typically at least \$100,000 unless it's a supplemental EIS relying on other information
- Streamlined review follow ordinance and clear bookends
- Avoid appeals under SEPA rely on Planned Action EIS

The LSDS Hybrid Form-Based Code would also reduce the complexity of permit applications, focusing on building form and street layout versus land use types. A decision on a Form-Based Code Review Application shall be based on the standard criteria for Process I Permits in the Lakewood Municipal Code and the following:

- 1. Consistency with the vision and policies of the Lakewood Comprehensive Plan.
- 2. Consistency with the vision and objectives of the Lakewood Station District Subarea Plan (LSDS.)
- 3. Compliance with the standards of the LSDS.
- 4. Compliance with the LSDS Planned Action.

SPECIAL TERMS AND CONDITIONS INTERAGENCY AGREEMENT STATE FUNDS

1. AUTHORITY

COMMERCE and Contractor enter into this Contract pursuant to the authority granted by Chapter 39.34 RCW.

2. CONTRACT MANAGEMENT

The Representative for each of the parties shall be responsible for and shall be the contact person for all communications and billings regarding the performance of this Contract.

The Representative for COMMERCE and their contact information are identified on the Face Sheet of this Contract.

The Representative for the Contractor and their contact information are identified on the Face Sheet of this Contract.

3. COMPENSATION

COMMERCE shall pay an amount not to exceed **one hundred thousand dollars (\$100,000)** the performance of all things necessary for or incidental to the performance of work under this Contract as set forth in the Scope of Work.

4. EXPENSES

Contractor shall receive reimbursement for travel and other expenses as identified below or as authorized in advance by COMMERCE as reimbursable.

Such expenses may include airfare (economy or coach class only), other transportation expenses, and lodging and subsistence necessary during periods of required travel. Contractor shall receive compensation for travel expenses at current state travel reimbursement rates.

5. BILLING PROCEDURES AND PAYMENT

COMMERCE will pay Contractor upon acceptance of services and deliverables provided and receipt of properly completed invoices, which shall be submitted to the Representative for COMMERCE not more often than quarterly.

The parties agree this is a performance-based contract intended to produce the deliverables identified in Scope of Work (Attachment A). Payment of any invoice shall be dependent upon COMMERCE'S acceptance of Contractor's performance and/or deliverable. The invoices shall describe and document, to COMMERCE's satisfaction, a description of the work performed, the progress of the project, and fees. The invoice shall include the Contract Number 20-63314-013. If expenses are invoiced, provide a detailed breakdown of each type. A receipt must accompany any single expenses in the amount of \$50.00 or more in order to receive reimbursement.

Payment shall be considered timely if made by COMMERCE within thirty (30) calendar days after receipt of properly completed invoices. Payment shall be sent to the address designated by the Contractor.

COMMERCE may, in its sole discretion, terminate the Contract or withhold payments claimed by the Contractor for services rendered if the Contractor fails to satisfactorily comply with any term or condition of this Contract.

No payments in advance or in anticipation of services or supplies to be provided under this Agreement shall be made by COMMERCE.

COMMERCE will pay Contractor for costs incurred prior to the start date of this Agreement, if such costs would have been allowable on or after July 28, 2019, the effective date of Engrossed Second Substitute House Bill 1923 (2019). To be allowable, such costs must be limited to the completion of tasks and deliverables outlined in the Scope of Work (Attachment A).

SPECIAL TERMS AND CONDITIONS INTERAGENCY AGREEMENT STATE FUNDS

Duplication of Billed Costs

The Contractor shall not bill COMMERCE for services performed under this Agreement, and COMMERCE shall not pay the Contractor, if the Contractor is entitled to payment or has been or will be paid by any other source, including grants, for that service.

Disallowed Costs

The Contractor is responsible for any audit exceptions or disallowed costs incurred by its own organization or that of its subcontractors.

Line Item Transfers

The total amount of transfers of funds between line item budget categories shall not exceed ten percent (10%) of the total budget. If the cumulative amount of these transfers exceeds or is expected to exceed ten percent, the total budget shall be subject to justification and negotiation of a contracts amendment by the Contractor and COMMERCE. However, the final deliverable for this grant must be remain thirty percent (30%) of the total grant award and payment for this final deliverable is contingent upon submittal of a copy of the final, adopted local action.

Ineligible Costs

Only eligible project-related costs will be reimbursed. Ineligible costs include, but are not necessarily limited to: capital expenses, such as land acquisition or construction costs; purchase of machinery; hosting expenses, such as meals, lodging, or transportation incurred by persons other than staff and volunteers working directly on the project; lobbying or political influencing; and other costs which are not directly related to the project.

6. INSURANCE

Each party certifies that it is self-insured under the State's or local government self-insurance liability or risk pool program and shall be responsible for losses for which it is found liable.

7. SUBCONTRACTOR DATA COLLECTION

1. **DEFINITIONS**

As used throughout this Contract, the following terms shall have the meaning set forth below:

- **A.** "Authorized Representative" shall mean the Director and/or the designee authorized in writing to act on the Director's behalf.
- **B.** "COMMERCE" shall mean the Department of Commerce.
- C. "Contract" or "Agreement" means the entire written agreement between COMMERCE and the Contractor, including any attachments, documents, or materials incorporated by reference. E-mail or facsimile transmission of a signed copy of this contract shall be the same as delivery of an original.
- **D.** "Contractor" shall mean the entity identified on the face sheet performing service(s) under this Contract, and shall include all employees and agents of the Contractor.
- E. "Personal Information" shall mean information identifiable to any person, including, but not limited to, information that relates to a person's name, health, finances, education, business, use or receipt of governmental services or other activities, addresses, telephone numbers, social security numbers, driver license numbers, other identifying numbers, and any financial identifiers.
- **F.** "State" shall mean the state of Washington.
- **G.** "Subcontractor" shall mean one not in the employment of the Contractor, who is performing all or part of those services under this Contract under a separate contract with the Contractor. The terms "subcontractor" and "subcontractors" mean subcontractor(s) in any tier.

2. ALL WRITINGS CONTAINED HEREIN

This Contract contains all the terms and conditions agreed upon by the parties. No other understandings, oral or otherwise, regarding the subject matter of this Contract shall be deemed to exist or to bind any of the parties hereto.

3. AMENDMENTS

This Contract may be amended by mutual agreement of the parties. Such amendments shall not be binding unless they are in writing and signed by personnel authorized to bind each of the parties.

Up to ten percent of the contract amount for each activity may be moved to another activity without a contract amendment.

4. ASSIGNMENT

Neither this Contract, work thereunder, nor any claim arising under this Contract, shall be transferred or assigned by the Contractor without prior written consent of COMMERCE.

5. CONFIDENTIALITY AND SAFEGUARDING OF INFORMATION

- A. "Confidential Information" as used in this section includes:
 - i. All material provided to the Contractor by COMMERCE that is designated as "confidential" by COMMERCE;
 - ii. All material produced by the Contractor that is designated as "confidential" by COMMERCE; and
 - iii. All personal information in the possession of the Contractor that may not be disclosed under state or federal law.
- B. The Contractor shall comply with all state and federal laws related to the use, sharing, transfer, sale, or disclosure of Confidential Information. The Contractor shall use Confidential Information solely for the purposes of this Contract and shall not use, share, transfer, sell or disclose any Confidential Information to any third party except with the prior written consent of COMMERCE or as may be required by law. The Contractor shall take all necessary steps to assure that Confidential Information is safeguarded to prevent unauthorized use, sharing, transfer, sale or disclosure of

Confidential Information or violation of any state or federal laws related thereto. Upon request, the Contractor shall provide COMMERCE with its policies and procedures on confidentiality. COMMERCE may require changes to such policies and procedures as they apply to this Contract whenever COMMERCE reasonably determines that changes are necessary to prevent unauthorized disclosures. The Contractor shall make the changes within the time period specified by COMMERCE. Upon request, the Contractor shall immediately return to COMMERCE any Confidential Information that COMMERCE reasonably determines has not been adequately protected by the Contractor against unauthorized disclosure.

C. Unauthorized Use or Disclosure. The Contractor shall notify COMMERCE within five (5) working days of any unauthorized use or disclosure of any confidential information, and shall take necessary steps to mitigate the harmful effects of such use or disclosure.

6. <u>COPYRIGHT</u>

Unless otherwise provided, all Materials produced under this Contract shall be considered "works for hire" as defined by the U.S. Copyright Act and shall be owned by COMMERCE. COMMERCE shall be considered the author of such Materials. In the event the Materials are not considered "works for hire" under the U.S. Copyright laws, the Contractor hereby irrevocably assigns all right, title, and interest in all Materials, including all intellectual property rights, moral rights, and rights of publicity to COMMERCE effective from the moment of creation of such Materials.

"Materials" means all items in any format and includes, but is not limited to, data, reports, documents, pamphlets, advertisements, books, magazines, surveys, studies, computer programs, films, tapes, and/or sound reproductions. "Ownership" includes the right to copyright, patent, register and the ability to transfer these rights.

For Materials that are delivered under the Contract, but that incorporate pre-existing materials not produced under the Contract, the Contractor hereby grants to COMMERCE a nonexclusive, royalty-free, irrevocable license (with rights to sublicense to others) in such Materials to translate, reproduce, distribute, prepare derivative works, publicly perform, and publicly display. The Contractor warrants and represents that the Contractor has all rights and permissions, including intellectual property rights, moral rights of publicity, necessary to grant such a license to COMMERCE.

The Contractor shall exert all reasonable effort to advise COMMERCE, at the time of delivery of Materials furnished under this Contract, of all known or potential invasions of privacy contained therein and of any portion of such document which was not produced in the performance of this Contract. The Contractor shall provide COMMERCE with prompt written notice of each notice or claim of infringement received by the Contractor with respect to any Materials delivered under this Contract. COMMERCE shall have the right to modify or remove any restrictive markings placed upon the Materials by the Contractor.

7. DISPUTES

In the event that a dispute arises under this Agreement, it shall be determined by a Dispute Board in the following manner: Each party to this Agreement shall appoint one member to the Dispute Board. The members so appointed shall jointly appoint an additional member to the Dispute Board. The Dispute Board shall review the facts, Agreement terms and applicable statutes and rules and make a determination of the dispute. The Dispute Board shall thereafter decide the dispute with the majority prevailing. The determination of the Dispute Board shall be final and binding on the parties hereto. As an alternative to this process, either of the parties may request intervention by the Governor, as provided by RCW 43.17.330, in which event the Governor's process will control.

8. GOVERNING LAW AND VENUE

This Contract shall be construed and interpreted in accordance with the laws of the state of Washington, and any applicable federal laws, and the venue of any action brought hereunder shall be in the Superior Court for Thurston County.

9. INDEPENDENT CAPACITY OF THE CONTRACTOR

The parties intend that an independent contractor relationship will be created by this Contract. The Contractor and its employees or agents performing under this Contract are not employees or agents of the state of Washington or COMMERCE. The Contractor will not hold itself out as or claim to be an officer or employee of COMMERCE or of the state of Washington by reason hereof, nor will the Contractor make any claim of right, privilege or benefit which would accrue to such officer or employee under law. Conduct and control of the work will be solely with the Contractor.

10. LICENSING, ACCREDITATION AND REGISTRATION

The Contractor shall comply with all applicable local, state, and federal licensing, accreditation and registration requirements or standards necessary for the performance of this Contract.

11. <u>RECAPTURE</u>

In the event that the Contractor fails to perform this Contract in accordance with state laws, federal laws, and/or the provisions of this Contract, COMMERCE reserves the right to recapture funds in an amount to compensate COMMERCE for the noncompliance in addition to any other remedies available at law or in equity.

Repayment by the Contractor of funds under this recapture provision shall occur within the time period specified by COMMERCE. In the alternative, COMMERCE may recapture such funds from payments due under this Contract.

12. RECORDS MAINTENANCE

The Contractor shall maintain books, records, documents, data and other evidence relating to this contract and performance of the services described herein, including but not limited to accounting procedures and practices that sufficiently and properly reflect all direct and indirect costs of any nature expended in the performance of this contract.

The Contractor shall retain such records for a period of six (6) years following the date of final payment. At no additional cost, these records, including materials generated under the contract, shall be subject at all reasonable times to inspection, review or audit by COMMERCE, personnel duly authorized by COMMERCE, the Office of the State Auditor, and federal and state officials so authorized by law, regulation or agreement.

If any litigation, claim or audit is started before the expiration of the six (6) year period, the records shall be retained until all litigation, claims, or audit findings involving the records have been resolved.

13. SAVINGS

In the event funding from state, federal, or other sources is withdrawn, reduced, or limited in any way after the effective date of this Contract and prior to normal completion, COMMERCE may suspend or terminate the Contract under the "Termination for Convenience" clause, without the ten calendar day notice requirement. In lieu of termination, the Contract may be amended to reflect the new funding limitations and conditions.

14. SEVERABILITY

The provisions of this contract are intended to be severable. If any term or provision is illegal or invalid for any reason whatsoever, such illegality or invalidity shall not affect the validity of the remainder of the contract.

15. SUBCONTRACTING

The Contractor may only subcontract work contemplated under this Contract if it obtains the prior written approval of COMMERCE.

If COMMERCE approves subcontracting, the Contractor shall maintain written procedures related to subcontracting, as well as copies of all subcontracts and records related to subcontracts. For cause, COMMERCE in writing may: (a) require the Contractor to amend its subcontracting procedures as they

relate to this Contract; (b) prohibit the Contractor from subcontracting with a particular person or entity; or (c) require the Contractor to rescind or amend a subcontract.

Every subcontract shall bind the Subcontractor to follow all applicable terms of this Contract. The Contractor is responsible to COMMERCE if the Subcontractor fails to comply with any applicable term or condition of this Contract. The Contractor shall appropriately monitor the activities of the Subcontractor to assure fiscal conditions of this Contract. In no event shall the existence of a subcontract operate to release or reduce the liability of the Contractor to COMMERCE for any breach in the performance of the Contractor's duties.

Every subcontract shall include a term that COMMERCE and the State of Washington are not liable for claims or damages arising from a Subcontractor's performance of the subcontract.

16. SURVIVAL

The terms, conditions, and warranties contained in this Contract that by their sense and context are intended to survive the completion of the performance, cancellation or termination of this Contract shall so survive.

17. TERMINATION FOR CAUSE

In the event COMMERCE determines the Contractor has failed to comply with the conditions of this contract in a timely manner, COMMERCE has the right to suspend or terminate this contract. Before suspending or terminating the contract, COMMERCE shall notify the Contractor in writing of the need to take corrective action. If corrective action is not taken within 30 calendar days, the contract may be terminated or suspended.

In the event of termination or suspension, the Contractor shall be liable for damages as authorized by law including, but not limited to, any cost difference between the original contract and the replacement or cover contract and all administrative costs directly related to the replacement contract, e.g., cost of the competitive bidding, mailing, advertising and staff time.

COMMERCE reserves the right to suspend all or part of the contract, withhold further payments, or prohibit the Contractor from incurring additional obligations of funds during investigation of the alleged compliance breach and pending corrective action by the Contractor or a decision by COMMERCE to terminate the contract. A termination shall be deemed a "Termination for Convenience" if it is determined that the Contractor: (1) was not in default; or (2) failure to perform was outside of his or her control, fault or negligence.

The rights and remedies of COMMERCE provided in this contract are not exclusive and are in addition to any other rights and remedies provided by law.

18. TERMINATION FOR CONVENIENCE

Except as otherwise provided in this Contract, COMMERCE may, by ten (10) business days written notice, beginning on the second day after the mailing, terminate this Contract, in whole or in part. If this Contract is so terminated, COMMERCE shall be liable only for payment required under the terms of this Contract for services rendered or goods delivered prior to the effective date of termination.

19. TERMINATION PROCEDURES

Upon termination of this contract, COMMERCE, in addition to any other rights provided in this contract, may require the Contractor to deliver to COMMERCE any property specifically produced or acquired for the performance of such part of this contract as has been terminated. The provisions of the "Treatment of Assets" clause shall apply in such property transfer.

COMMERCE shall pay to the Contractor the agreed upon price, if separately stated, for completed work and services accepted by COMMERCE, and the amount agreed upon by the Contractor and COMMERCE for (i) completed work and services for which no separate price is stated, (ii) partially completed work and services, (iii) other property or services that are accepted by COMMERCE, and (iv) the protection and preservation of property, unless the termination is for default, in which case the Authorized Representative shall determine the extent of the liability of COMMERCE. Failure to agree with such determination shall be a dispute within the meaning of the "Disputes" clause of this contract.

COMMERCE may withhold from any amounts due the Contractor such sum as the Authorized Representative determines to be necessary to protect COMMERCE against potential loss or liability.

The rights and remedies of COMMERCE provided in this section shall not be exclusive and are in addition to any other rights and remedies provided by law or under this contract.

After receipt of a notice of termination, and except as otherwise directed by the Authorized Representative, the Contractor shall:

- A. Stop work under the contract on the date, and to the extent specified, in the notice;
- B. Place no further orders or subcontracts for materials, services, or facilities except as may be necessary for completion of such portion of the work under the contract that is not terminated;
- C. Assign to COMMERCE, in the manner, at the times, and to the extent directed by the Authorized Representative, all of the rights, title, and interest of the Contractor under the orders and subcontracts so terminated, in which case COMMERCE has the right, at its discretion, to settle or pay any or all claims arising out of the termination of such orders and subcontracts;
- D. Settle all outstanding liabilities and all claims arising out of such termination of orders and subcontracts, with the approval or ratification of the Authorized Representative to the extent the Authorized Representative may require, which approval or ratification shall be final for all the purposes of this clause;
- E. Transfer title to COMMERCE and deliver in the manner, at the times, and to the extent directed by the Authorized Representative any property which, if the contract had been completed, would have been required to be furnished to COMMERCE;
- F. Complete performance of such part of the work as shall not have been terminated by the Authorized Representative; and
- G. Take such action as may be necessary, or as the Authorized Representative may direct, for the protection and preservation of the property related to this contract, which is in the possession of the Contractor and in which the Authorized Representative has or may acquire an interest.

20. TREATMENT OF ASSETS

Title to all property furnished by COMMERCE shall remain in COMMERCE. Title to all property furnished by the Contractor, for the cost of which the Contractor is entitled to be reimbursed as a direct item of cost under this contract, shall pass to and vest in COMMERCE upon delivery of such property by the Contractor. Title to other property, the cost of which is reimbursable to the Contractor under this contract, shall pass to and vest in COMMERCE upon (i) issuance for use of such property in the performance of this contract, or (ii) commencement of use of such property in the performance of this contract, or (iii) reimbursement of the cost thereof by COMMERCE in whole or in part, whichever first occurs.

- A. Any property of COMMERCE furnished to the Contractor shall, unless otherwise provided herein or approved by COMMERCE, be used only for the performance of this contract.
- B. The Contractor shall be responsible for any loss or damage to property of COMMERCE that results from the negligence of the Contractor or which results from the failure on the part of the Contractor to maintain and administer that property in accordance with sound management practices.
- C. If any COMMERCE property is lost, destroyed or damaged, the Contractor shall immediately notify COMMERCE and shall take all reasonable steps to protect the property from further damage.
- D. The Contractor shall surrender to COMMERCE all property of COMMERCE prior to settlement upon completion, termination or cancellation of this contract

All reference to the Contractor under this clause shall also include Contractor's employees, agents or Subcontractors.

21. WAIVER

Waiver of any default or breach shall not be deemed to be a waiver of any subsequent default or breach. Any waiver shall not be construed to be a modification of the terms of this Contract unless stated to be such in writing and signed by Authorized Representative of COMMERCE.

CITY COUNCIL PUBLIC HEARING MONDAY JANUARY 6, 2020

VACATION REQUEST SUMMARY:

Ward R. Melby, the owner of real property directly adjacent to the right-of-way to be vacated, has submitted a request to vacate the southwest 70 feet of Walnut Ave. SW. The portion of right-of-way to be vacated is approximately 4,200 square feet in size and abuts parcel numbers 0219103078 and 5015000090. The legal representative of owners of parcel number 5015000090, Eugene & Margaret Bal, signed the vacation petition and is supportive of the proposed division of the vacated right-of-way per the attached survey and vicinity map.

The property was acquired by Pierce County more than 25 years ago for right-of-way purposes, to which the City became heir upon incorporation. Therefore, staff is recommending the applicant pay to the City \$37,800 which represents full appraised value (reference Lakewood Municipal Code (LMC) 12.12.160).

- **Petition:** Ward R. Melby acting as Principal Petitioner. The Principal Petitioner is the owner of the adjoining parcel to the proposed vacated area. The additional petitioner is Lily Sherman representing the Bal Family Revocable Living Trust. A copy of the vacation petition is attached.
- **Notification:** On November 18, 2019, the Lakewood City Council passed Resolution No. 2019-20 establishing January 6, 2020, as the date for a public hearing to be held before the City Council on the proposed vacation. In accordance with LMC 12.12.090, all

property owners of record, within 300 feet of the limits of the proposed vacation (according to the records of the Pierce County Assessor), were notified by mail of the time, place and purpose of the hearing. A notice of the hearing was published in the Tacoma News Tribune on December 19, 2019. A placard was posted at the site where the vacation is being requested.

In accordance with the LMC 12.12.120, the following criteria are to be considered in determining whether to vacate a street or alley:

- A. Whether a change of use or vacation of the street or alley will better serve the public good;
- B. Whether the street or alley is no longer required for public use or public access;
- C. Whether the substitution of a new and different public way would be more useful to the public;
- D. Whether conditions may so change in the future as to provide a greater use or need than presently exists; and
- E. Whether objections to the proposed vacation are made by owners of private property (exclusive of petitioners) abutting the street or alley or other governmental agencies or members of the general public.

Discussion of how the proposed vacation conforms to the aforementioned criteria.

- A. The vacation of the southwest 70 feet of Walnut Ave SW, a dead-end street, located east of Langlow St SW will not alter the existing use of the right-of-way for the public. Vacation of this unused portion of Walnut Ave SW will better serve the public good than a change of use.
- B. The Public Works Engineering Department has determined that the public right-of-way to be vacated is not required for public use or for public access.
- C. The substitution of new and different public right-of-way will not be more useful.
- D. It is not anticipated that conditions may so change in the future as to provide a greater need for the right-of-way proposed to be vacated.
- E. No written objections to the vacation have been received by the City from private property owners, other governmental agencies, or the general public.

Department and Agency Recommendations:

Public Works Engineering Department:

Staff believes that the proposed vacation conforms to the criteria in LMC Chapter 12.12, Street and Alley Vacation Procedures. If the City Council chooses to approve the proposed vacation, the following conditions should be imposed:

1. The vacation shall be effective upon payment to the City of Lakewood, within 120 days of the date hereof, by the owner of the property or assignee adjacent thereto and to be benefited by the vacation, in the amount which represents full appraised value of the 4,200 square feet of right-of-way to be vacated.

2. The City shall retain an easement or the right to exercise and grant easements in respect to the vacated land for the construction, repair, and maintenance of public utilities and services.

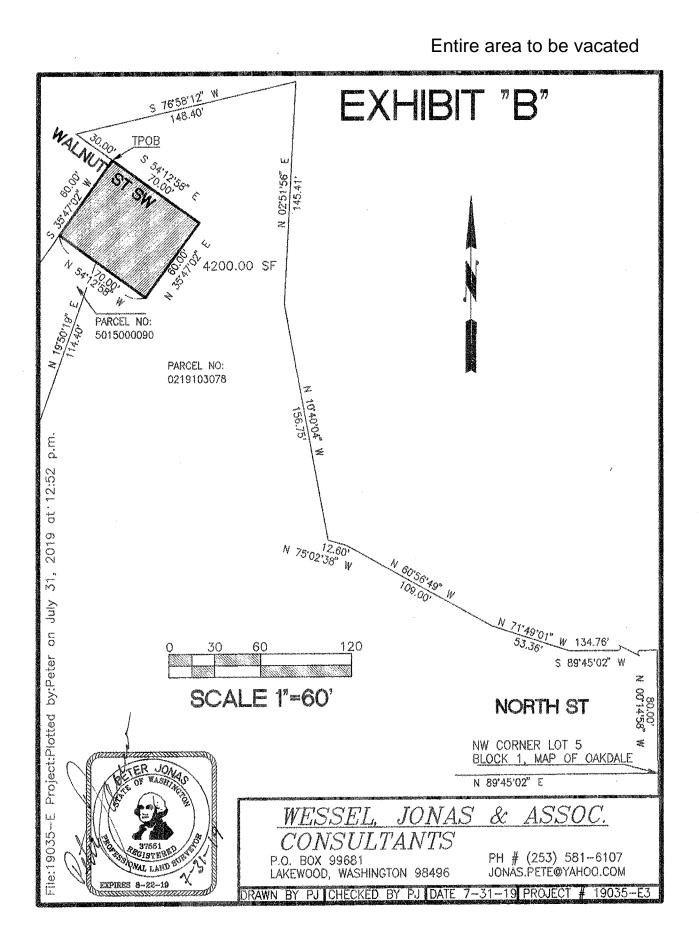

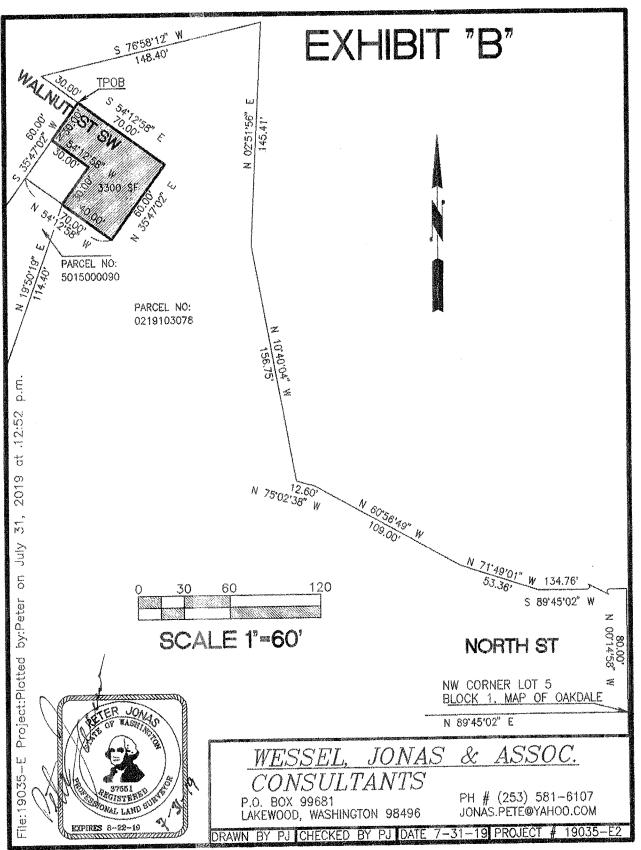

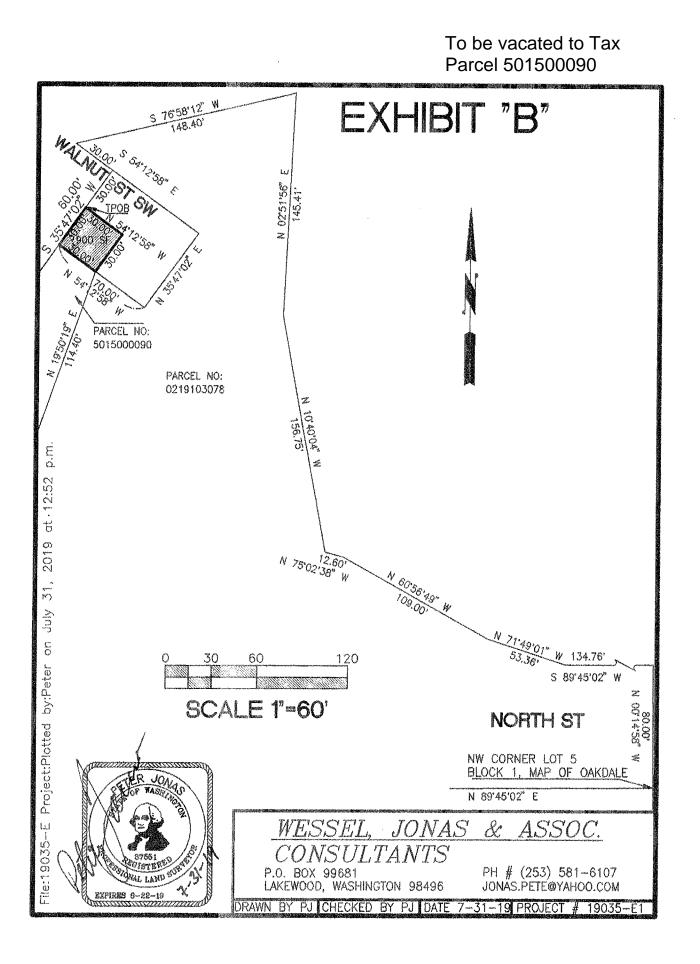

City of Lakewood Public Hearing 16 December 2019 City of Lakewood Support for Proposed CPSD Levy 2020

I oppose the proposed Clover Park School District (CPSD) levy.

The proposed levy has an annualized increase of 5.94% over each of 4 years! What other costs have risen that fast? Perhaps the school board needs to get a dose of reality and propose a levy more in line with the region's economic situation and current flat line or decline in enrollment. We already spend more per student than other districts which are outperforming CPSD.

This levy is based upon rising property values, even at the same \$2.50 mil rate, rather than on any demonstrable increase in the cost of or benefit to education. As property values climb, the education levy tags along for the ride and gets to fill out its wish list. The CPSD budget shouldn't be expanded just to soak up the revenue from a hoped for inflated housing market. This levy proposal hands CPSD a blank check hinged on the vagaries of the local real estate market rather than the cost or benefit to education. The City of Lakewood did this with budget deliberations in 2007 when they bet on a rising real estate market and ran headlong into the real estate crash of 2008.

Throwing money at the "problem" of education is not a solution but part of the problem. CP SD must be held accountable for levies ostensibly for improving our children's education. We need measurable goals, not just generalities, for each levy before we support it: things like graduation rates, college admissions, test scoring, student competency and so forth. The board and staff also need to be held individually accountable for any failure to achieve these goals.

We cannot continue to pour money into a system which is failing. "Give us more money, people and 'stuff' so we can do it poorly faster" isn't reason enough to pass this levy. It's a smoke screen that covers real systemic problems at CPSD. Rather, the school district needs to change how it operates to turn things around where it matters most: student achievement in education.

Thank you for taking comments on the proposed education levy. Before I begin, I would like to request additional time to speak on behalf of Citizens for Responsible Educational Funding as I was approved by the School Board to write the against statement in the voters' guide.

My Name is Kerry Hills and I grew up in Lakewood and attended the Clover Park School System from k-12. As the Districts own mission statement notes it is their job to ensure each child learns what he or she needs to know to succeed and contribute to the community. As I have mentioned before the district is currently failing, and has for many years, to fully educate the students of our community and meet their mission statement. As we all know it is difficult to fully contribute to the community with a less than adequate education.

This is not my personal opinion; however, these are the facts as published by the Office of Public Instruction (OPI). The information shows that over 56% of the students are not meeting the standards as set by the State. We expected the State to fully fund education, which it has through the McCleary Decision, so why do we allow the District to fall short on there commitment to the students. Last year only 52% of all 9th Graders passed all of their classes according to OPI. I am quite sure that when I was in school anything less than 60% was failing. An F is the grade our district currently earns. In fact, the information from OPI goes even deeper to show that in both math and science the longer a student stays in the District the more likely they are to fail at meeting the standards. While about 40% of 5th Graders meet the standards in math and science only about 30% of 10th and 11th Graders meet that same standard.

At last week's school board meeting one of the board members ask if testing is the best way for us to measure if the students are succeeding. This statement only increases my concern as it shows that the facts are being ignored and there may be little desire to correct the short comings of the current system.

As I mentioned, the McCleary Decision already fully funds CPSD but this District, unlike many, also gets a great deal of funding in Military Impact Aide. To provide an education the State average is just over \$11,000 per student per year. In CPSD the tax payers spend an additional \$5000 more per student per year. To that I ask . . . Why should we continue to spend those extra tax dollars when the district produces consistently low-test scores?

At the start of each school year some district always strikes and the news reports that better teacher pay and smaller classes will improve education. While I am not convinced that continuing to throw good money at a failing education system is an adequate resolution the School Board funded significant teacher raises last year in CPSD. Do you realize what "under paid teachers earn?" The Kitsap Sun has published all teachers wages statewide. In that publication you can look up your favorite teachers' pay. Brand New Teachers in CPSD start about \$50k per year and some veteran teachers are earning over \$100,000 per year. That to me is not under paid. There are comparable occupations that require a college degree where the workforce earns less. I don't expect any of you to take me at my word but review the proof I have put before you from several different sources.

STATE LEGISLATIVE POSITIONS 2020

As superintendents of the Puget Sound region representing nearly 40% of students across Washington state, 53% of whom are students of color, our unwavering focus is on students. Our legislative priorities are aimed to create opportunities for each and every student to succeed in school and in life, and to eliminate opportunity gaps based on race, income and other factors that have historically disadvantaged young people.

We recognize that the Legislature has made progress in implementing a new funding system for K-12 education. The state must continue to adjust the funding system to match the policies it has set and to meet student needs today.

Update Staff Allocation Formulas

The need for student supports in local school districts has grown exponentially, yet the funding ratios for many staff positions in the prototypical school model have not kept up. In particular, schools need additional capacity to hire staff to support the social and emotional needs of students and to engage families in culturally relevant and authentic ways.

Proposed Solution: Phase in updated ratios, considering recommendations from the Staffing Enrichment Workgroup.

Special Education Funding

Prior to the 2019 session, OSPI identified a special education underfunded need of more than \$300 million. The 2019-21 budget provides \$80 million -- a much-needed investment in the safety net, yet far from full funding.

Proposed Solution: Increase the special education multiplier to make up for the full costs districts are required to incur.

Support School Facilities

Many districts continue to have difficulty passing local requests for, building, and maintaining modern school facilities.

Proposed Solution: Advance a constitutional amendment to the people authorizing school district bond issues to be approved with a simple majority vote. Additionally, update the construction and space formulas to ensure funding more closely reflects actual costs and educational space needs.

School Employee Benefit (SEB) Impacts

The 2019 Legislature took action to fund and ratify the SEB Collective Bargaining Agreement, with the program beginning January 1, 2020. Unfortunately, the costs of the new benefit program and the state funding do not align. As the new insurance program is implemented, adjustments are needed to fund the full costs to school districts.

Proposed Solution: Align SEB policies and related funding including the costs of substitute/part-time employee eligibility and employees that opt-out of coverage.

Student and Staff Safety & Wellness

In 2019, the Legislature passed HB 1216, a hallmark school safety policy and the first of its kind in Washington state. The bill has formalized a comprehensive statewide, regionally-based delivery model that is coordinated with school staff, mental health practitioners, and other community professionals, such as emergency responders, to better ensure our schools receive timely, relevant and seamless health and safety supports. Although the legislature passed this policy, less than 25% of the activities required by HB 1216 were funded.

Proposed Solution: Fully fund the statewide school safety and student well-being network, regional school safety centers, and statewide support for behavioral health and suicide prevention. 113

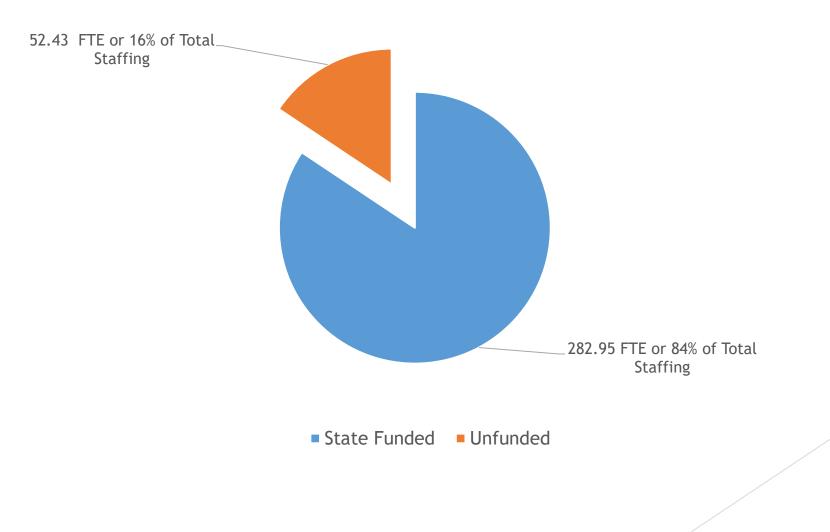

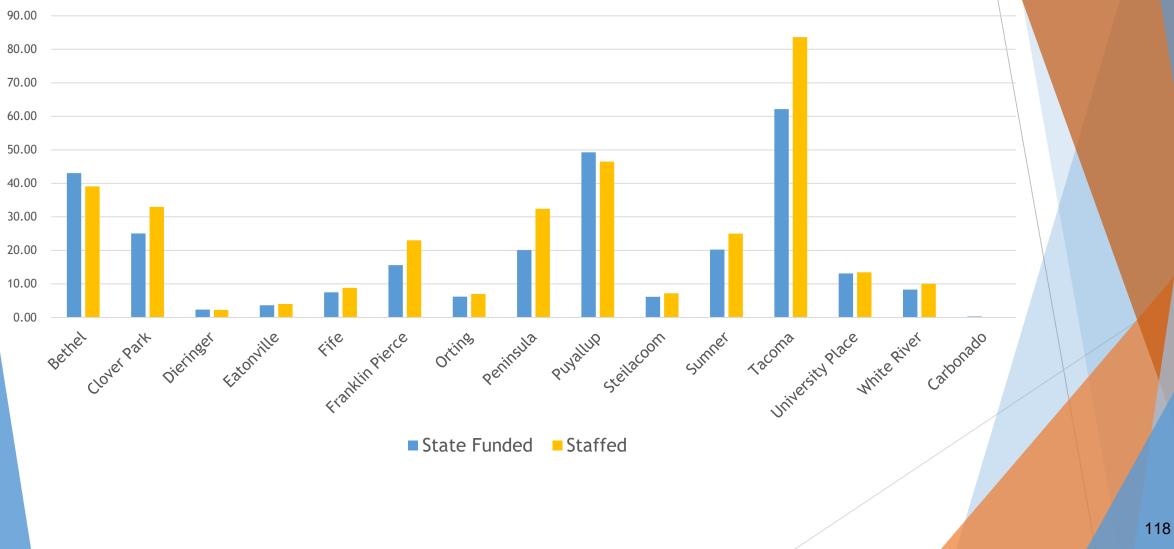
Of Note:

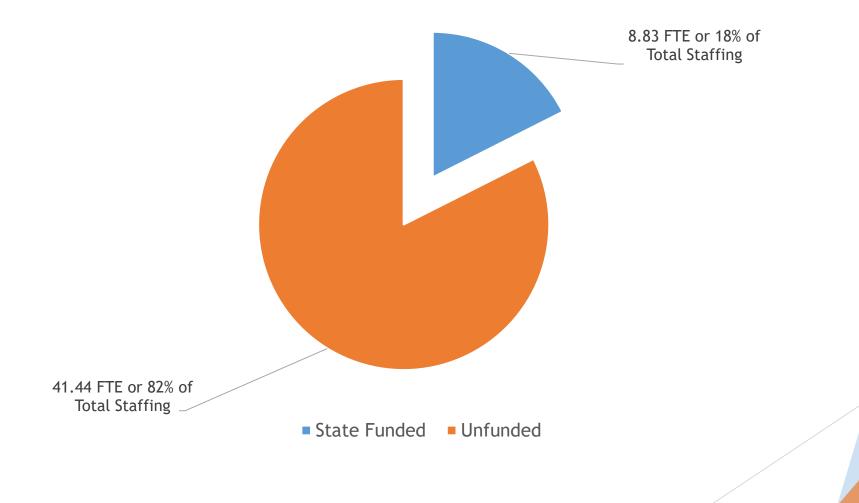
Pierce County School Districts State Funded vs. Unfunded Counselors



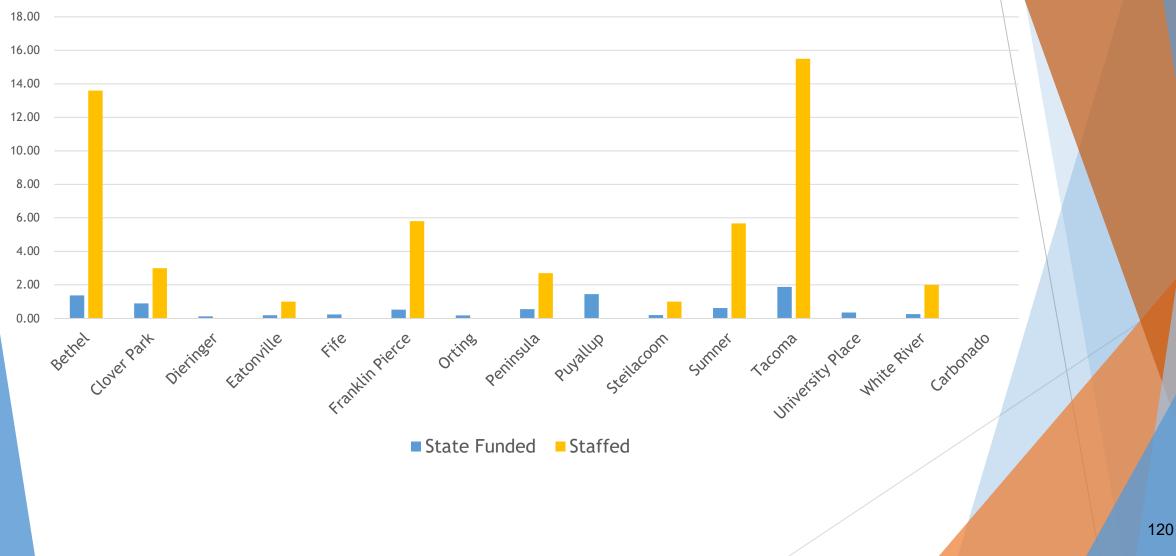
Pierce County School Districts State Funded vs. Staffed Counselors



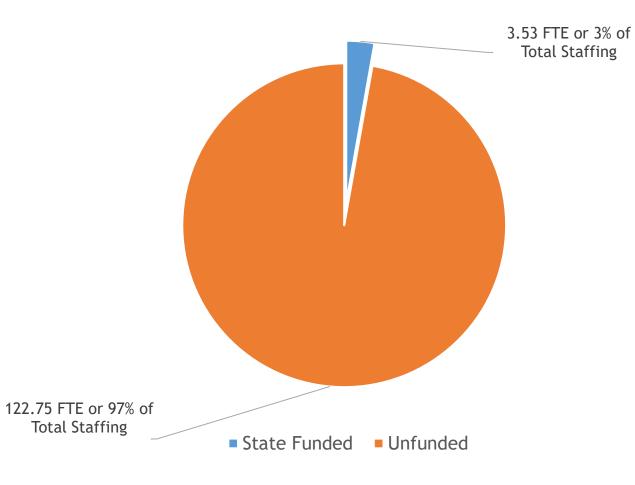
Pierce County School Districts State Funded vs. Unfunded Social Workers



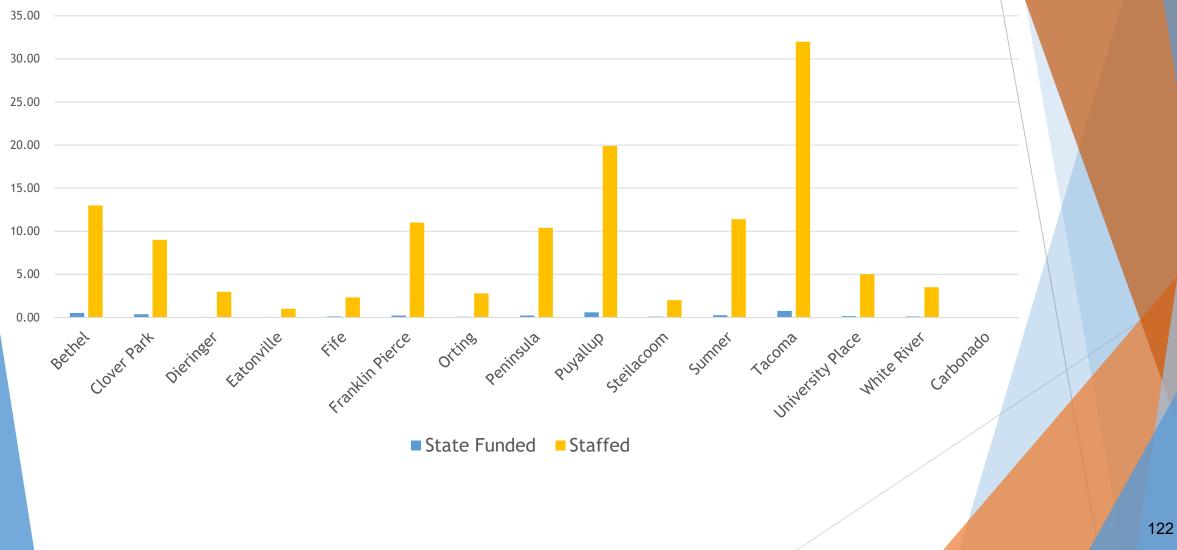
Pierce County School Districts State Funded vs. Staffed Social Workers

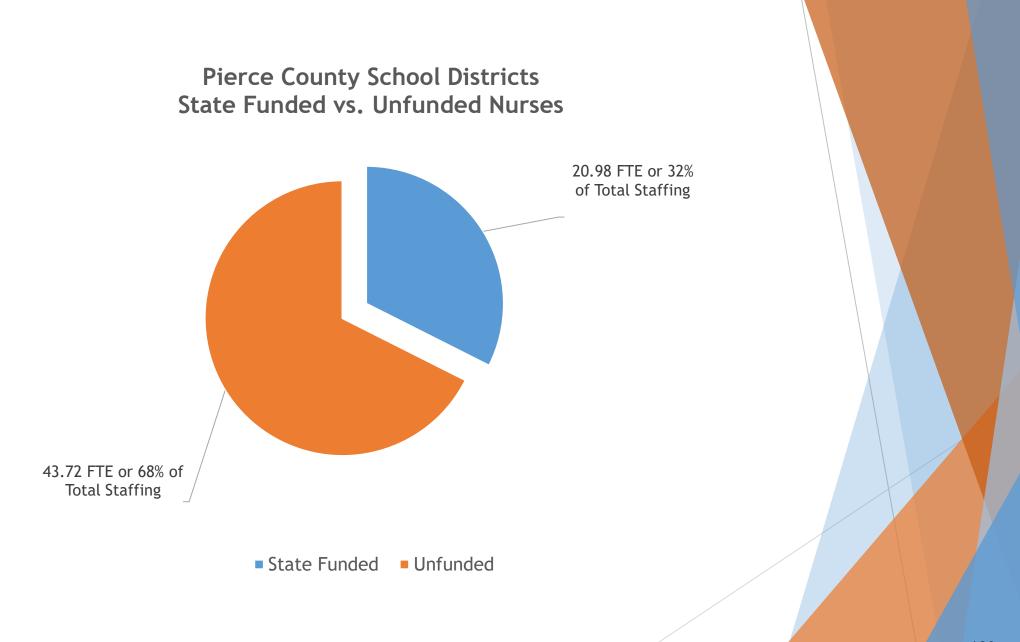


Pierce County School Districts State Funded vs. Unfunded Psychologists

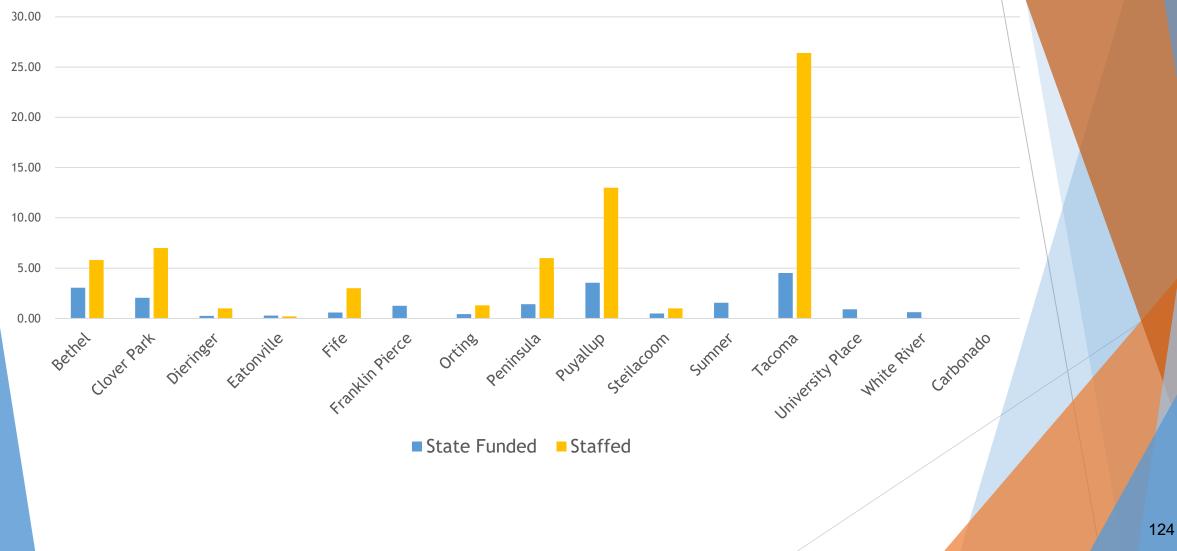

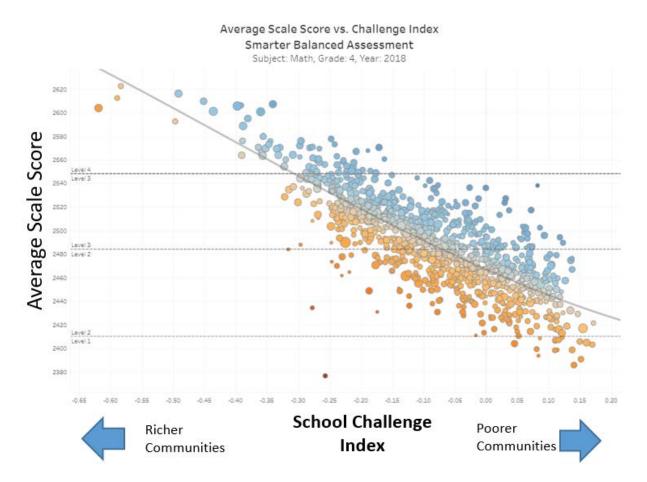

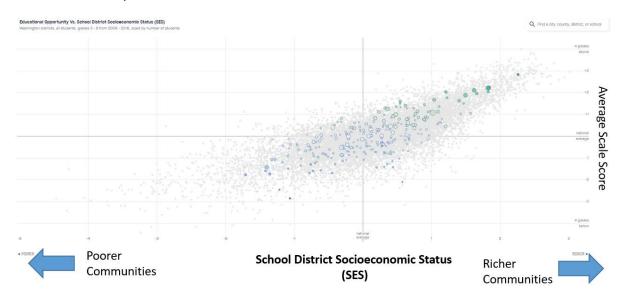
Placing Proficiency in the Proper Context: Family Wealth Matters

Average Test Scores (or % meeting standard) are metrics that reflect educational opportunity and are closely associated with the socioeconomic status (SES) of families served by a school district. Proficiency should not be used as the primary indicator of school/district quality since students are influenced by a range of experiences outside the school. For example, in comparing the proficiency rates of students in the Clover Park School District to students in the Mercer Island School District, one may conclude that Mercer Island is more effective because their proficiency rates are much higher. However, more students may have attended high quality preschool programs in Mercer Island than in Clover Park since families who can afford to live on Mercer Island can also afford to invest in supplemental, educational programs for their children while most families in Clover Park do not have this opportunity. The wealth of a community matters and its strong relationship with academic achievement is well documented. The following visuals are from two separate sources and illustrate the relationship between average scale score and socioeconomic status.

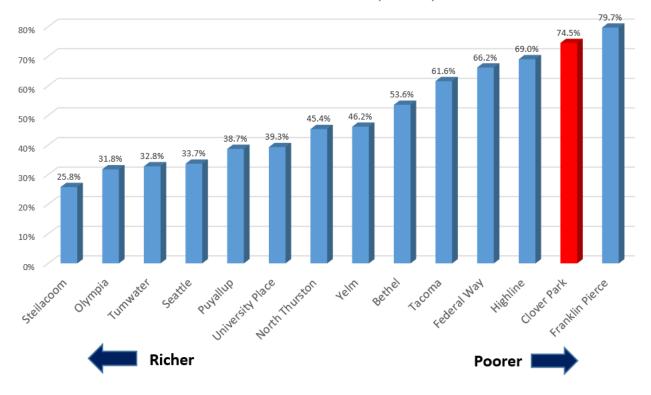


Communities serving wealthier families are on the left side of the above scatterplot, while communities serving poorer families are on the right side. The wealthier the district, the higher the average scale score.

The same relationship holds in the scatterplot below created by The Educational Opportunity Project at Stanford University:

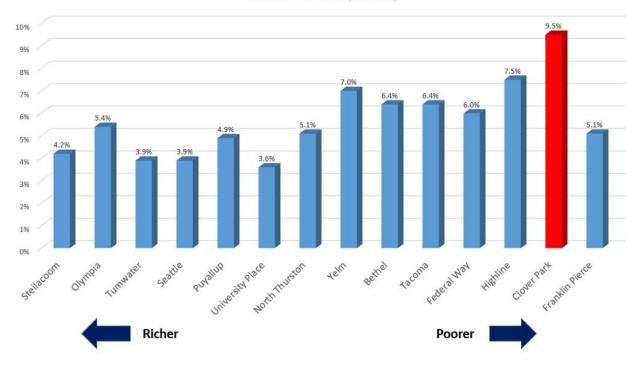


How poor is Clover Park School District compared to its peers? Of its 13 peers, Clover Park serves the second to the poorest student population; 74.5% of students in Clover Park qualify for free/reduced-priced meals.



% Low Income Students (2018-19)

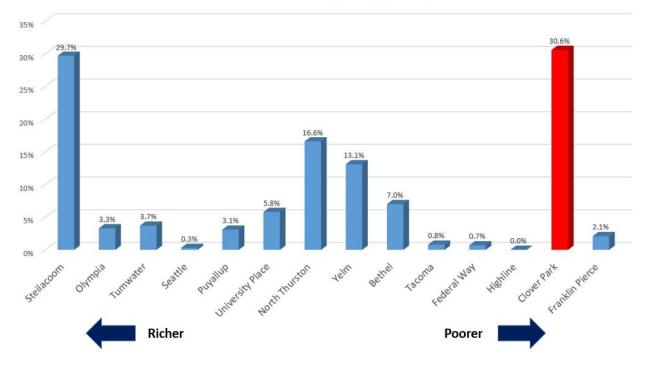
Placing proficiency data in the proper socioeconomic context is important but there is an additional, unique challenge also faced by the families that Clover Park serves – high student mobility. High student mobility is also known to negatively influence proficiency rates.

Why is the community served by Clover Park so highly mobile? Other than the fact that high poverty families tend to be more mobile, military families also tend to be more mobile. Clover Park serves more military families than any of its neighboring peer districts.

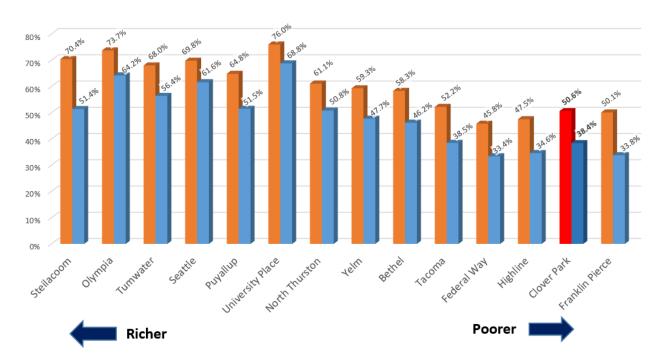




Clover Park Proficiency vs Peer Districts

Part II: Academic Growth

The best metric to use to understand the effectiveness of a school district is not the percent of its students meeting standard. Instead, academic growth (or learning rates) should be used.

Why is academic growth a better measure of school/district effectiveness?

Many of our students enter our schools with low levels of proficiency because they come from poorer, disadvantaged backgrounds. Clover Park School District cannot change the proficiency level of students that enter our schools. However, the district can impact how much students learn and grow while they are in our district.

What is academic growth?

Academic growth is a measure of how much a student's score improves from one year to the next. OSPI uses the Median Student Growth Percentile (MSGP) to measure the academic growth of a school or district. A MSGP of 50 would mean average growth. A MSGP below 50 is below average growth while a MSGP above 50 is above average growth.

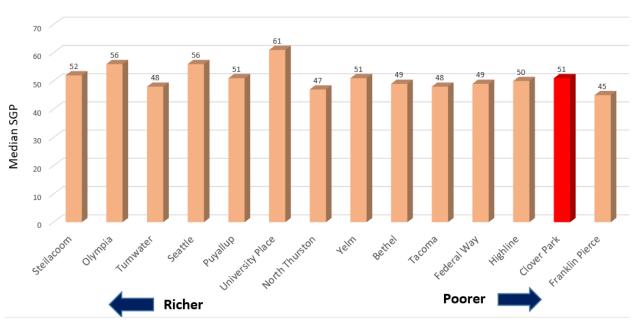
Comparing Clover Park Academic Growth to its Peers

This part of the report will compare academic growth performance between Clover Park and its peer districts using 2 sources:

- 1. OSPI, which measures academic growth for all districts in WA State from 2016 to 2019
- 2. The Educational Opportunity Project at Stanford University, which measures the learning rates of districts nationwide between 2008 and 2016.

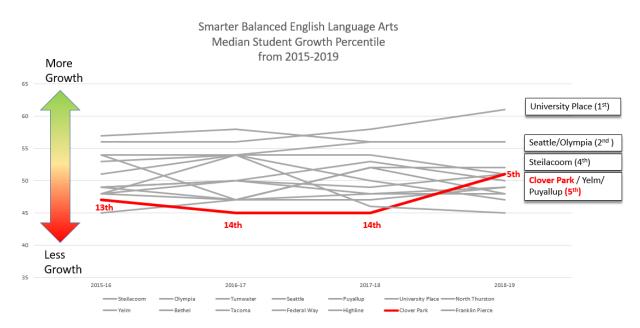
English Language Arts (ELA): Although Clover Park is the 2nd poorest district with much higher student mobility compared to its neighbors, it still ranks 5th of the 14 peer districts in English Language Arts student growth.

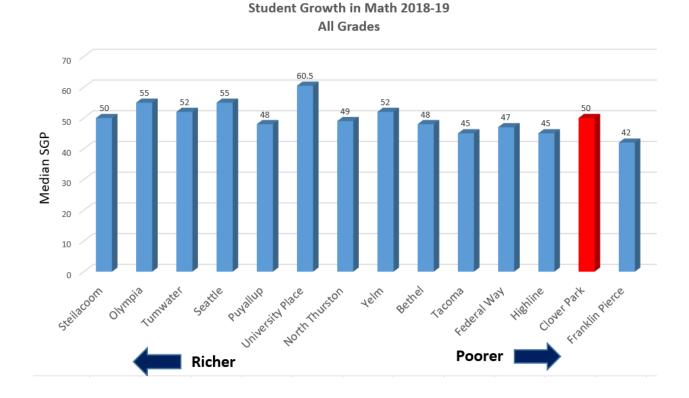


Student Growth in English Language Arts 2018-19 All Grades

English Language Arts Academic Growth over Time

Clover Park had the greatest improvement of student growth in English Language Arts (ELA) between the 2015-16 and 2018-19 school years. Clover Park's students are tied with **Yelm** and **Puyallup** for having the 5th strongest in academic growth in ELA amongst their peer districts.

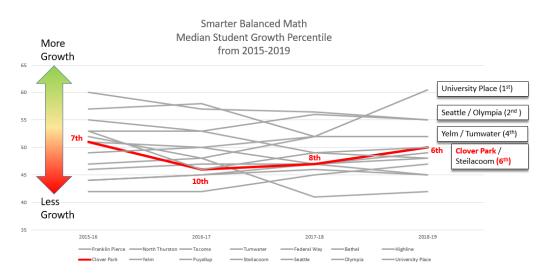




Math: Clover Park ranks 6th of the 14 districts in math student growth with a median student growth percentile that is considerably higher than its socioeconomic peers.

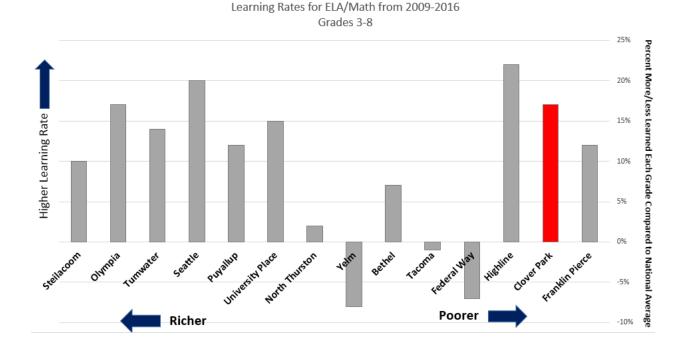
Math Academic Growth over Time

Academic Growth Evidence from the Educational Opportunity Project at Stanford University

The Educational Opportunity Project measures learning rates which is how much students' scores improve each year while they are in school. Like student growth, the learning rate is a better indicator of a district's impact on student learning than the percent of students meeting standard, which is influenced by a range of student experiences outside the school.



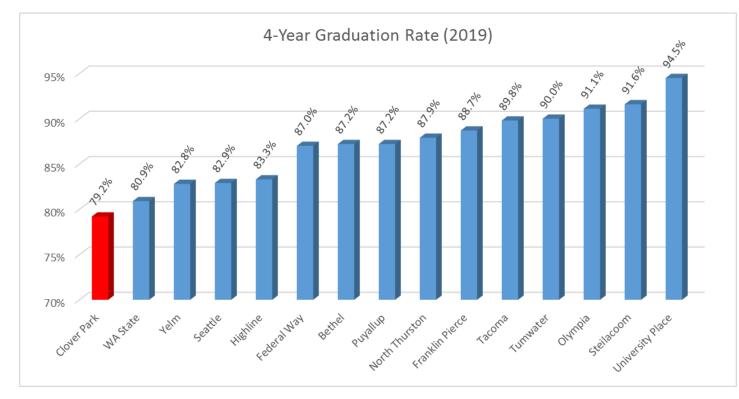
These data indicate that over the course of 8 years (from 2009-2016), students in Clover Park learned 17 percent more than the US national average. Amongst its peer group, our district is tied for 3rd in this measure with Olympia. Only students in Highline and Seattle exceeded our learning rate in this peer comparison group.



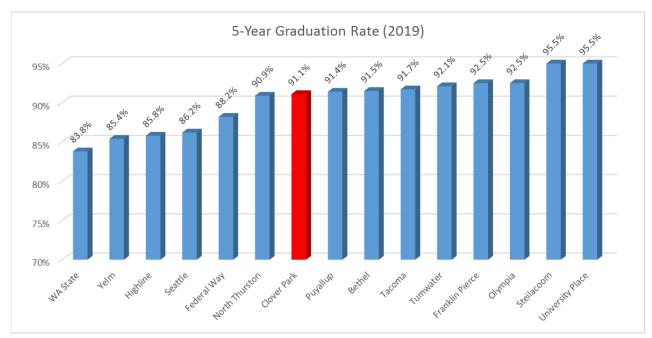
Part III: Graduation Rate

Official school/district graduation rates are released by OSPI in early to mid-December and reflect the graduation rates of the previous academic year. These data are slow to arrive in school districts because the process of calculating graduation rates is time consuming. OSPI has to track the whereabouts of high school students who transfer between schools in Washington state and relies on individual districts to inform them if a student transfers out of the state or into a private school. Students who are unaccounted for are considered "drop outs" by the state. Unlike test scores, graduation rates can change over time as students who moved out of a district are eventually accounted for and reported to OSPI.

The following bar chart compares Clover Park's 2019 cohort's 4-year graduation rate with that of its peer districts.



Despite Clover Park having the lowest 4-year graduation rate of its peers, the Clover Park's 5-year graduation rate of 91.1% positions it solidly in the middle of pack of its peer districts and 7.3 percentage points higher than the state's 5-year graduation rate.

Subject:	Wide-Format Printer & Scanner Replacements

Background

The city currently utilizes two (2) Hewlett Packard wide-format printers which are shared amongst several departments at City Hall. These printers were installed over 10 years ago and have exceeded their manufacturer's life expectancy. Over the past year we have provided continued maintenance and support on these printers. The cost of toner, maintenance, parts and support is now increasing for both units which mandates us to look at replacements for each of these machines. Along with the wide-format printers at City Hall, there is a single KIP unit that is used to scan large wide-format prints for all departments. This unit is an older model that is slow and very inefficient when scanning wide-format prints. It also requires an extensive amount of staff time to scan due to the systems slow response. As we begin to look at the document management solution implementation, it will be crucial to have a quality scanner in-house that will provide a means to scan existing wide-format prints. This will reduce third party costs by providing staff with a fast and efficient unit that can be used to scan documents internally and not having to outsource all large wide-format documents to third parties.

Recommendation

- Replace the existing wide format printers with the HP PageWide XL40000 printer. This printer has a production rate of 8- 24x36 prints per minute for both color and black and white prints. Print quality is constant at 1,200 DPI and provides a wide range of media selection to include bond, photo, Mylar, banner, clear film, poster & vinyl. These units will allow for more precise, high quality prints at a lower cost per print the current models. Total 1-time cost of \$32,420 funded by 2019 savings from printer & copier supplies and other various line items.
- Purchase the IQ Quattro 4450 Pro-Station scanner which provides up to 44" Color and B&W support. Separate print & scan functions by purchasing a stand-alone efficient wide-format scanner. This system will increase production and increase life expectancy of any wide-format printer that both prints & scans. The scanner also fits in to the upcoming document management solution well by providing an efficient unit to scan wide-format documents. Total 1-time cost of \$7,968 funded by 2019 savings from printer & copier supplies and other various line items.

The purpose of this memo is to provide Council an update on the Onyx Drive project. Through this project the city will add pedestrian facilities along Onyx Drive from 97th Avenue to 87th Avenue (west segment) and from Garnet Lane to Phillips Road (east segment). Both segments together are approximately 1.3 miles in length. BCRA is the design consultant.

KEY DESIGN ELEMENTS

- complete roadway reconstruction of the west segment and overlay of the east segment
- complete storm water conveyance and treatment system
- 12 foot lane in each direction with no center turn lane
- 8 foot wide shared pedestrian/bicycle sidewalk on the south side of the road with a 2 foot wide hardscape buffer
- 6 foot wide sidewalk on the north side of the road
- street lighting utilizing a color temperature suited for the residential environment
- raised cross walks at 97th Avenue, 78th Street, and Coral Lane
- feedback radar speed signs
- replacement of individual mail boxes to cluster type mailboxes where feasible
- realignment of the Onyx/Onyx and Phillips Intersection

The original scope of the project was to construct a shared sidewalk along one side of the roadway only. The south side of the roadway has significantly fewer driveways compared to the north side thereby reducing the pedestrian/vehicle conflicts and making it the more suitable location for the shared sidewalk. However, the majority of the pedestrian generators (neighborhoods) are located to the north of the road making direct access to a facility on the south side challenging. Because of this, BCRA was tasked to develop a cost estimate for the inclusion of sidewalks on the north side of the road. The budget discussion below includes a standard sidewalk on the north side and the shared sidewalk on the south side of the road.

The traffic analysis for the intersection controls at both 87th and at Phillips concluded that roundabouts were not necessary from an operational or Level of Service standpoint but that realignment of the Onyx/Onyx/Phillips intersection would reduce conflict and driver confusion. BCRA was able to realign this intersection and add a left turn pocket onto Onyx (both legs) within the existing right of way; attached is a schematic depicting this new configuration. To address speeding concerns, raised crosswalks will be installed at key intersections and feedback radar speed signs will be installed in each direction of travel along both the east and west segments.

Due to the nature of the development, constructing the improvements will have significant impacts on existing trees and in some cases private landscape features within and beyond the existing right of way. BCRA is consulting with an arborist to possibly reduce these impacts however at current count there are approximately 190 trees that will likely need to be removed. This includes approximately 2 dozen trees located on private property. BCRA and staff will meet with residents one on one whose private landscaping improvements are impacted. Staff will also update all residents fronting the project limits in the coming weeks via a direct mailer.

SCHEDULE

BCRA is currently working towards 100% design documents and is on target to advertise for construction in early February 2020. Construction is anticipated to begin in April 2020 and continue into late fall/winter.

BUDGET

Below is the estimated costs and available budget for the project.

The costs shown are based on a 90% design level and therefor include a 5% construction contingency. As design progresses to 100%, this contingency will decrease. The current value of the 5% construction contingency is \$209,000.

At the current design level, the project budget exceeds expenses by \$127,800. This includes the addition of the sidewalks on the north side of the road (additional \$380,000). Engineer's estimates are typically in the middle of the pack when bids are opened. As the project progresses to 100% bid ready documents, we will re-evaluate anticipated costs vs. available funding. Should it be necessary, we will return to council with a construction funding recommendation.

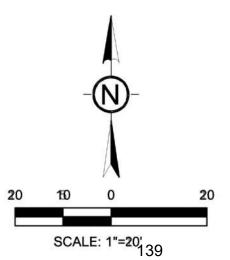

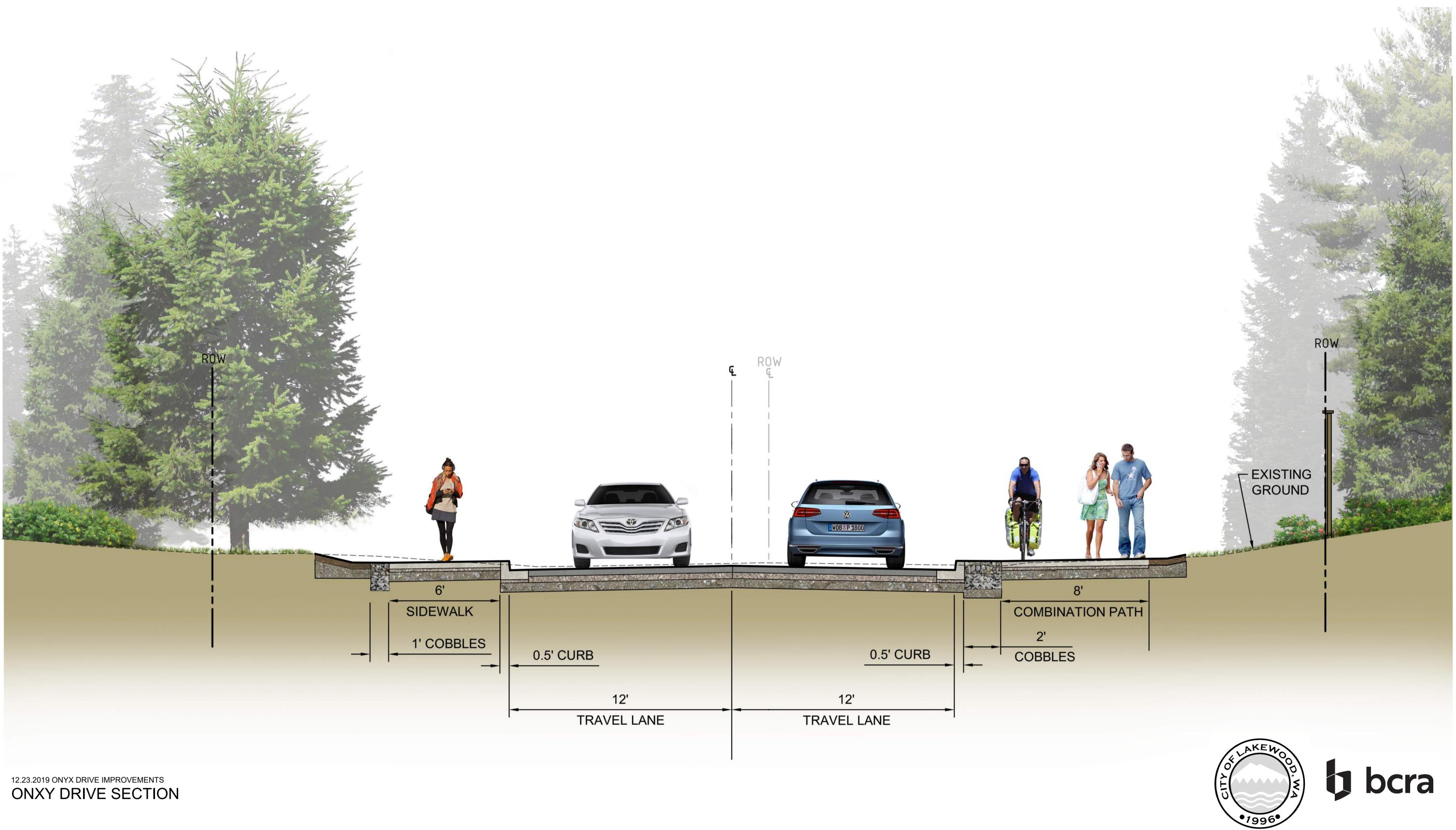

The purpose of this memo is to provide Council an update on the Veterans Drive project. Through this project, the City will reconstruct Veterans Drive from Gravelly Lake Drive to the American Lake Park with the potential to extend to the V.A. Hospital grounds entrance. The City secured \$2,000,000 in Connecting Washington grant funds to construct the Lake City Business District segment (Alameda to American Lake Park) of the project and the City committed to constructing the segment from Gravelly Lake Drive to Alameda utilizing General Obligation Bond funds. While funding was initially planned for construction only from Gravelly Lake Drive to American Lake Park, the design includes the entire corridor from Gravelly Lake Drive to the American Lake V.A. Hospital grounds entrance (city limits) and improvements to parking at the American Lake Park, intended to offset the loss of informal on-street parking.

KEY DESIGN ELEMENTS

- removal of concrete pavement and complete roadway reconstruction
- complete storm water conveyance and treatment system
- 12 foot lane in each direction with no center turn lane
- 10 foot wide shared pedestrian/bicycle path on the south side of the road with a 5 foot wide limited landscape/hardscape buffer
- 7 foot wide sidewalk on the north side of the road with limited tree wells
- street lighting utilizing a color temperature suited for the residential environment
- roundabouts at Lake City Blvd, Vernon, and Dolly Madison
- feedback radar speed signs
- replacement of individual mail boxes to cluster type mailboxes
- expansion of the American Lake Park parking lot to add 40 standard parking spaces

SCHEDULE

Parametrix is currently working towards 100% design documents. The 90% review documents will be delivered January 24 and the project remains on target to be advertise for construction mid-February. Construction is anticipated to begin in April 2020 and continue into winter.

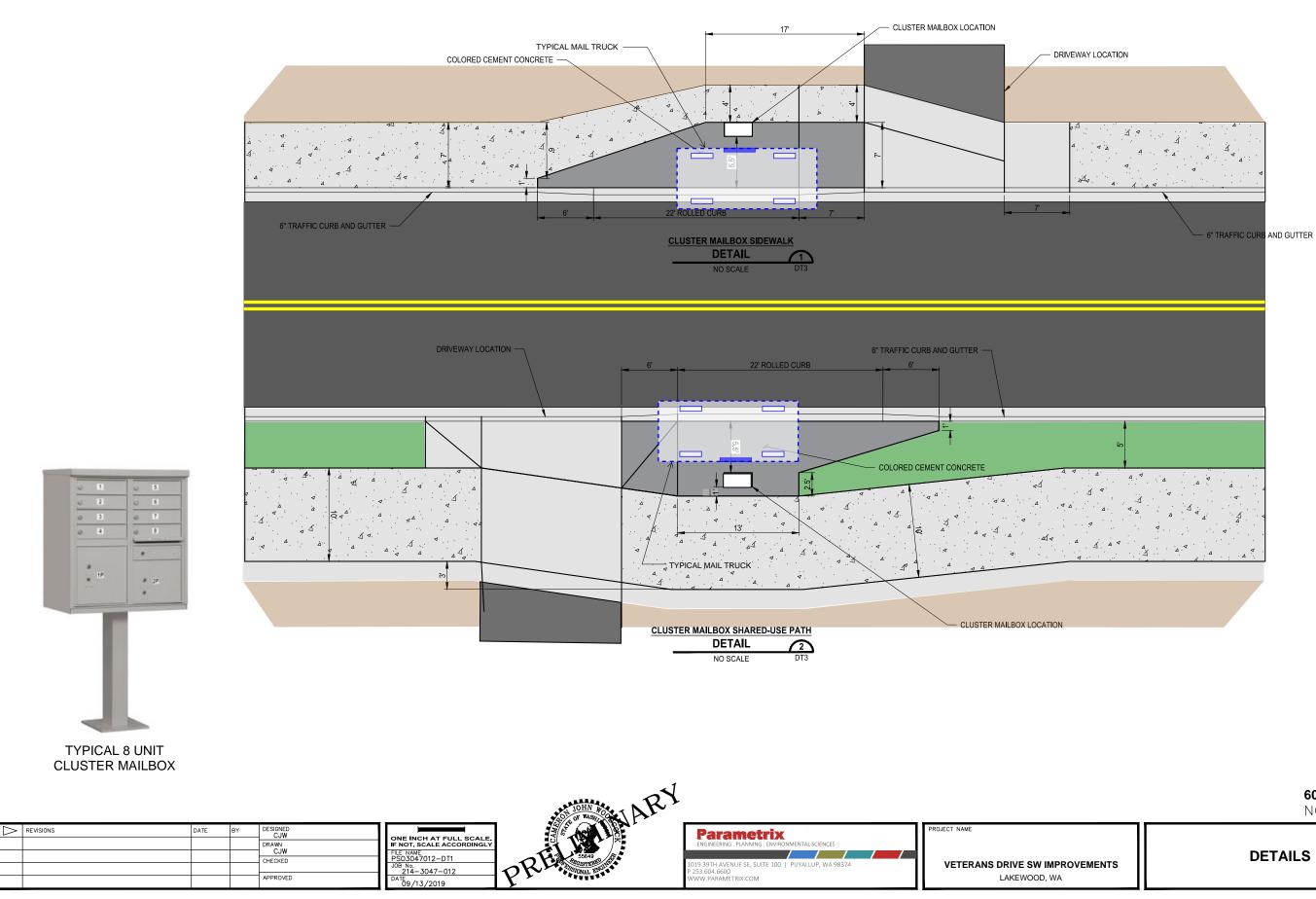
BUDGET

Attached is the estimated costs and available budget for the project.

The costs shown are based on a 60% design level and therefor include a 15% construction contingency. As design progresses to 100%, this contingency will decrease. The current value of the 15% construction contingency for the entire corridor is \$1,008,992.

At the current design level, the project costs exceed available funding by \$1,280,597 should the entire corridor and parking lot expansion be constructed. This estimate includes a construction contingency in excess of \$1M. It is not unusual for cost estimates early in the design process to be at or even over allocated funding. Additionally, engineer's estimates are typically in the middle of the pack when bids are opened. As the project progresses to 100% bid ready documents, we will re-evaluate anticipated costs vs. available funding. Should it be necessary, we will return to council with a construction funding recommendation.

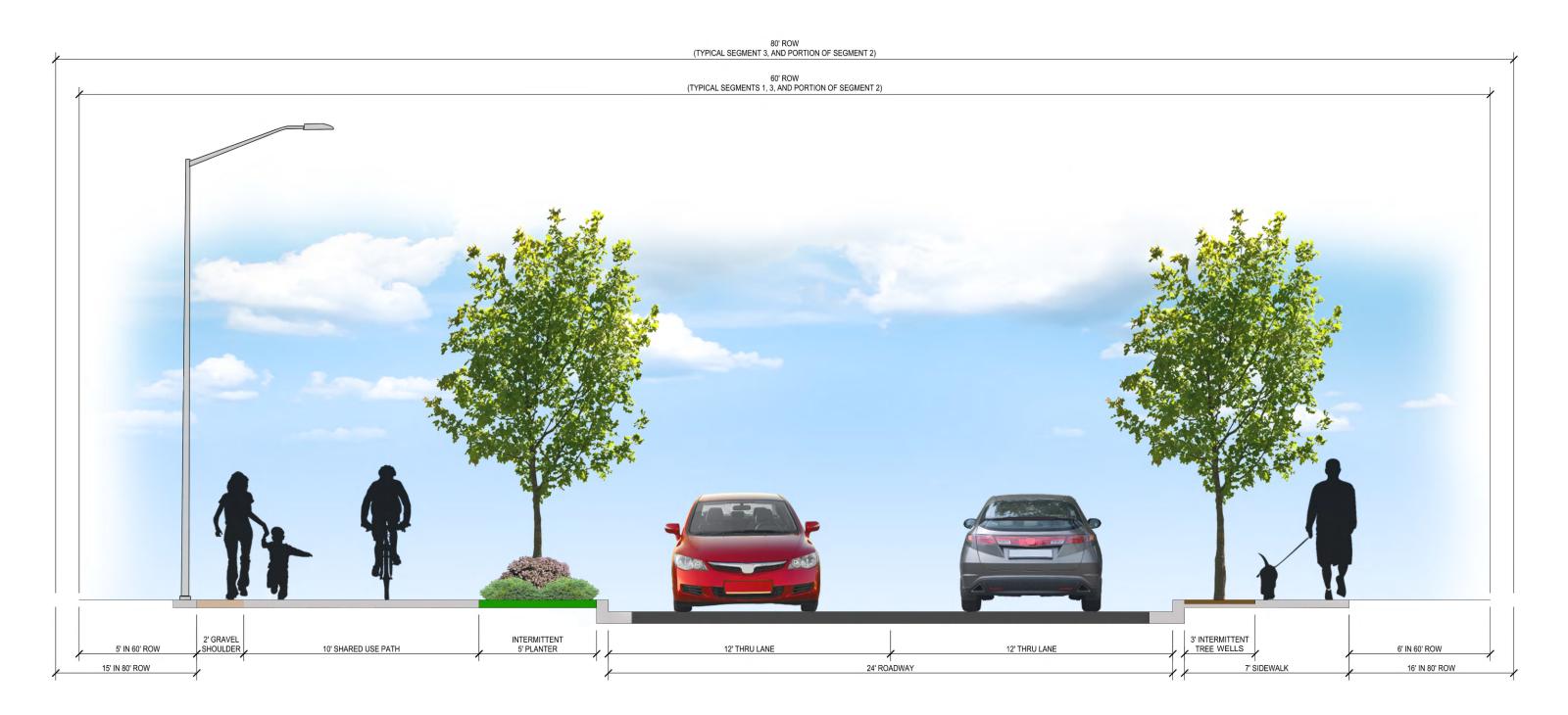
