Workforce Demographics

Demographics for the department's commissioned officers were provided. The total number decreased by one for each quarter. The March 30 total was 94 officers, June 30 was 93, and September 30 was 92.

Examiner's Report

- Currently, there are active job postings for Lieutenant, Entry Police Officer, and Lateral Police Officer.
- The Lieutenant posting closes on November 8. This process includes an assessment center which will be held in mid-January.
- The Entry Police Officer job posting closes on December 31. Testing will be on January 15.
- Staffing changes since the July 29 meeting include the retirements of Detective Bryan Johnson on December 1, Detective Ryan Larson on August 20, Officer Dave Butts on November 30, Officer Darrin Latimer on July 31, and Officer Paul Osness on October 31.
- Officers Travis Elisara, Zachary Schueller, and Melody Wright resigned in November.

- New hires are Officers Grant Boere, Rader Cockle, and Cole Craner.
- Currently, we have approval to fill nine Police Officer positions. A conditional offer was made to David Dougherty. An additional three conditional offers will be made after this meeting.
- Heidi Wachter reported that there are no applicants for the position of Commissioner. Chairman Boyd said he will serve on an interim basis until a new Commissioner is appointed.

The meeting was adjourned at 10:03 a.m.
