### CALL TO ORDER

The meeting was called to order at 5:16 p.m.

### **APPROVAL OF MINUTES**

Karen Ferreira asked about paragraph three under "New Business" which seemed to end abruptly; Joanna LaVergne stated she was correct and she would fix that. Alan Hart motioned to approve the amended August meeting minutes. All ayes; minutes approved.

### CITY COUNCIL LIAISON COMMENTS

Councilmember Mike Brandstetter stated that the City was still working on allocating the ARPA funds, but some decisions have been made that relate to public safety. This includes providing funding to purchase body cameras for our police officers, as well as the staffing to make that system run smoothly. Councilmember Brandstetter discussed some other projects the City is looking at funding with the ARPA funds. Discussion ensued.

### FIRE CHIEF COMMENTS

Assistant Fire Chief Scott Adams discussed the Red Flag Warning in effect back in August, which was effectively a burn ban. Chief Adams also discussed the 9/11 ceremony, the WPFR newsletter, Fall Safety Day coming up on the 23<sup>rd</sup>, WPFR Fire Prevention classes which are being sent out to the schools via the website, and the 7 lateral fire fighters they have hired this year. Discussion ensued.

### POLICE CHIEF COMMENTS

Chief Michael Zaro gave a hiring update. Mark Peila asked how the vaccine mandates were affecting the department; Chief Zaro stated the current mandates only affect State employees, not City, and thus do not apply to Lakewood PD. Discussion ensued.

James Hairston asked about the problem of people running red lights, which seemed to be on the rise; Chief Zaro stated that red light cameras were the best deterrent, but they aren't very popular. Traffic emphases would be another great avenue, but we are currently understaffed, so doing extra emphases right now is difficult. Discussion ensued.

Alan Hart asked about the homelessness issue and the street racing issue which had been ramping up over the summer. Chief Zaro stated the street racing issues seemed to have peaked for Lakewood, once summer ended, especially, and that homelessness is an issue that seems to ebb and flow. Mr. Hart also asked about the feasibility of creating a citizens committee to lobby legislature regarding the public safety laws which have been passed. Discussion ensued.

Mark Terry asked about the uptick in graffiti/tagging across the city. Discussion ensued regarding taggers and the difficulties of keeping them off the streets, especially right now.

Chief Zaro shared about the Real Men Wear Pink campaign, for Breast Cancer Awareness Month, in which he is participating for the month of October, especially in honor of one our staff members who is currently battling breast cancer, as well as everyone else we know who have fought, or are still fighting, the disease.

It was agreed that the work plan would be finalized at the next meeting. If anyone has any more ideas, please email them to Joanna LaVergne.

Joanna LaVergne reminded everyone about the Fallen Officer Food Drive which is taking place on December 1<sup>st</sup> this year, which coincidentally is the date of the next PSAC Meeting. This meant she would have to send a replacement to the meeting. Alan Hart motioned that the committee move the meeting to December 8<sup>th</sup> instead. All ayes; the December PSAC meeting will be on December 8<sup>th</sup> at 5:15 p.m. via Zoom.


# NIBRS Total Crime By Quarter 2018-2021




### **NIBRS Person Crime By Quarter 2018-2021**




## **NIBRS Property Crime By Quarter 2018-2021**




## **NIBRS Society Crimes By Quarter 2018-2021**





### Motor Vehicle Theft 1Q2018-3Q2021






# 3rd Quarter 2021 Significant Incident Recap

- Shooting Investigation July 25<sup>th</sup>: Lakewood officers responded to a shooting at the Lakewood Village Apartments and discovered 19 casings and two rounds that passed through a wall; one lodging in a 3 year old's headboard and one bullet coming to a stop against the 3 year old's shoulder causing a burn.
- Shooting July 30<sup>th</sup>:Officers responded to the area of Steilacoom Blvd and John Dower a shooting where an older Lakewood Hustler Crip was having a party that was engaged by some Eastside Pirus. Eight 9mm, seven .223 and one .40 caliber casings were located.
- Homicide August 14<sup>th</sup>: Detectives from Lakewood Major Crimes responded to Karwan Village, 2621 84th St S to a badly decomposed, deceased male with a suspicious wound (ME confirmed as a gunshot) to the chest. The mobile unit was condemned and boarded up but apparently used by transients. Identification of the deceased was difficult. Detectives had located an EBT card and specific tattoos led to an identification of a transient male. The investigation is ongoing.
- Homicide (self defense) September 2<sup>nd</sup>: Lakewood units responded to Stay Fresh Tattoo studio at 10241 Bridgeport Way for a shooting. Upon arrival, officers found one victim with multiple gunshot wounds (later pronounced dead) and a second victim shot in the hip. The investigation indicates two people (brother and sister) arriving at the studio, confronting a tattoo artist which resulted in guns being produced and fired. The male who had confronted the tattoo artist was subsequently shot and killed. That person's sister then picked up her brother's gun and shot a person otherwise uninvolved. The female was arrested.
- Officer Involved Shooting- On Sept. 5<sup>th</sup> Officers from multiple jurisdictions responded to the 7300 block of 150<sup>th</sup> ST SW for reports of a male shooting off numerous rounds in an apartment complex parking lot. An arriving Lakewood officer advised SS911 dispatch that officers were being shot at and an officer involved shooting was called out moments later. PCFIT is conducting the ongoing investigation.
- Shooting- September 12<sup>th</sup>: Officers responded to the Woodspring Estates Hotel at 11329 Pacific Hwy and located a male victim with a gunshot wound to his leg. Subsequent investigation shows what started as a cell phone sale and attempted robbery.
   Apparently, the robbery went badly so the suspect pulled a gun and shot the victim. That suspect is known and remains at large.
- Drive by Shooting
   — September 24<sup>th</sup>: Lakewood officers responded to 12825 Pacific Hwy for a drive by shooting. The victim had already been taken to St Clare Hospital. Investigations shows the suspect fired 42 rounds at a group of people standing outside a local business. One person was struck in the chest by gunfire and subsequently paralyzed. Detectives identified the shooter and he was arrested in Tucson, Arizona, on October 13<sup>th</sup>. The motive appears to be drug related.
