MINUTES

Call to Order

Commissioner Roden called the meeting to order at 9:30 a.m.

Approval of Minutes

It was moved and seconded to approve the minutes for the February 3, 2022 meeting. The motion carried unanimously.

City Attorney Wachter commented that the minutes don't show an actual vote on all items moved and seconded because the vote didn't take place. With a three member board she doesn't believe a correction is required. Ms. Wachter noted that the record reflects that there was consideration by the entire board, a motion made by one of three, a second made from a second of three, and no dissent expressed in the discussion. It's very clear what the intent of the board was.

New Business

Cancellation of Eligibility

It was moved and seconded to disqualify Jaryd Garrett from the Entry Level Police Officer eligibility list. The motion carried unanimously.

Certification of Entry Level Police Officer Eligibility List

Workforce Demographics

Demographics for the department's commissioned officers were provided. A glitch was discovered in the supporting spreadsheet of data and has been resolved. The 1st, 2nd, and 3rd quarter of 2021 charts reflect corrections made in the columns for White males, total Officers, and total Detectives. A comparison of the December and September numbers reveals December increases for White males, White females, and Asian females. These categories each increased by one. Males for two or more races decreased by one in December. Commissioner Roden noted the increase of female representation from seven to eleven over the year, a substantial increase, from 7.4% to 12%.

Examiner's Report

- Officer Scott Novasky retired at the end of February.
- Detectives Chris Bowl and Brent Eggleston will retire in May and June respectively.
- There are 50 applicants eligible to take the Entry Police Officer written exam.
- The Detective eligibility list was extended one last time at the Chief's request. The list will now expire October 1st rather than April 1st.
- Ms. Wachter announced that as a result of Covid changes, the commission meeting in April may be an in person meeting with a virtual component to allow for public accessibility. Future meetings will likely be a hybrid of the on-site meeting at city hall and virtual meeting model. More information will be shared as we learn more.

It was moved and seconded to adjourn the meeting. The motion passed unanimously.
