REPORTS BY HISTORIC PRESERVATION OFFICER OR STAFF

New Member Mr. Mark Hayes

Mr. Ramon Rodriguez introduced the newest member, Mr. Mark Hayes. Mr. Hayes provided the board information on his background and his interest in the local history.

UNFINISHED BUSINESS

Driving Tour Map Update

During the March 24th meeting the board requested the map be scaled in order to show more of the City including Chambers Creek Trail and Woodbrook/Tillicum area. Members decided to amend the map to include significant parks in the City. The list includes American Lake Park, Chambers Creek Trail, Fort Steilacoom Park, and Harry Todd Park.

Ms. Courtney Brunell has scheduled a meeting next week with the Tribal Administrator of the Nisqually Tribe to discuss ways for both groups to collaborate and bring tribal history onto the map. Board members suggested information on the Ft. Steilacoom Park prairie and how the indigenous people used the herbs and flowers from that area. Other ideas included information on the ancestral lands used for fishing and hunting grounds or the Indian wars and battles in the area. Members are anxious to learn what viewpoints will be offered from the tribe. Ideas discussed in the tribal meeting will be shared at the May 26th meeting.

NEW BUSINESS

Clover Park School District Outreach

Ms. Brunell contacted President Ms. Sue Potter to invite to attend a future LHAB meeting to discuss partnering opportunities such as a pop-up museum, historic markers, designation, and future membership.

<u>Lakewood Historical Society Outreach</u>

Ms. Brunell contacted Ms. Leanna Albrecht, Director of Marketing and Community Relations & Grant Twyman, Director for Equity and Community Engagement to invite to attend a future meeting to discuss partnering opportunities of continued curriculum of Lakewood History and creating short "History of Lakewood" videos.

Termination of the Historic Designation for the Hopkins House

Ms. Brunell was notified by the owners of the Hopkins House requesting termination of the historic designation for the house stating their reverse mortgage has been denied as a result of the designation. Ms. Brunell has posted a scheduled public hearing with the board during the May 26, 2002.

Our reverse mortgage has been turned down as a result of the designation.





SUBJECT: Hopkins House Termination of Historic Designation Public Hearing

Background:

On April 28, 2022 the City received a request from Mrs. Priscilla Hopkins to terminate the Lakewood Landmarks Designation on her primary residence located at 7520 North Street SW, Lakewood, WA 98498 which is a designated Lakewood Landmark known as the "Hopkins House".

The Hopkins House was designated a Lakewood Landmark via proclamation in 2007.

Code Review:

The process for terminating a Lakewood Landmark designation are outlined in LMC 2.48.040

"A. Any person, including any member of the Board, may nominate an historic resource for designation as a landmark or community landmark. Procedures set forth may be used to amend existing designations or to **terminate** an existing designation based on changes which affect the applicability of the criteria for designation..."

The Landmarks and Heritage Advisory Board reviewed the request on April 28th during their regularly scheduled meeting.

Notice of the Public Hearing was published pursuant to LMC 2.48.050 on May 16, 2022.

Next Steps:

LMC 2.48.060

"A. After the conclusion of the required public hearing, the Board may recommend approval, denial, amendment or termination of the designation of a historic resource as a landmark or community landmark...

D A copy of the Board's recommendation shall be delivered or mailed to the owner, to interested persons of record and the City Manager within five working days after it is issued. Upon receipt by the City Manager of the Board's recommendation that a nomination be approved, the recommendation shall also be set for consideration by the City Council no less than 30 and no later than 60 days after the date of the recommendation. The City Council shall be the final authority in approving a nomination. . .

E. If the City approves or amends a landmark designation, the provisions of this chapter shall apply as approved or amended. A copy of the Board's designation report or designation amendment shall be filed with the appropriate City office together with a legal description of the designated resource and notification that the provisions of this chapter apply. If the City terminates the designation of an historic resource, the provisions of this chapter shall no longer apply to said historic resource."

Recommendation:

- 1. On May 26, 2022 open the public hearing to receive public testimony, close the public hearing.
- 2. Take action to approve the applicants request to terminate the designation, forward request onto the City Council for final approval

SUBJECT: Tree Preservation code update

Background:

In late summer, 2021, the City Council directed the City Manager to move forward and begin the process to amend the City's tree preservation code (Title 18, Chapter 18.70, Article III).

In late 2021, the City Council approved a contract with BERK consulting and PlanIT GEO including a scope of work, public participation plan and contract to rewrite/update the tree preservation code. Additionally, the City Council approved the formation of a Tree Advisory Ad Hoc Committee, which was charged with providing recommendations to the Planning Commission and City Council.

The Tree Adhoc Committee opportunity was advertised for 30 days in December, 2021- January, 2022. Applications were reviewed by the City Council and appointments were made in February, 2022. Beginning in March, the adhoc committee met a total of seven times, with an expected conclusion on April 28, 2022.

On May 4th & May 18th the Planning Commission began their review of the committee's recommendations. Planning Commission review is anticipated to continue throughout June & July, 2022.

Discussion:

During the May 26, 2022 meeting staff will provide an introduction to the tree preservation code update including an overview of the existing code, identification of critical issues, adhoc committee recommendations and next steps.

Next Steps:

The Planning Commission public hearing is tentatively scheduled for July 6, 2022. Comments will be accepted in writing through June 30th, 2022 or in person/ virtual testimony the day of the meeting.

If there is desire, the Landmarks and Heritage Advisory Board may draft comments to forward onto the Planning Commission, alternatively any member of the public may choose to submit comments individually. This agenda item can be included in the June 26, 2022 agenda packet.
