# **PUBLIC HEARINGS**

Hopkins House Termination of Historic Designation Request

Ms. Courtney Brunell explained to board members during a conversation the bank representative stated the appraisal of the property was difficult because there are no like properties to compare and assess against. The appraisal could not be completed. This is not an issue for a new purchase however it is a larger issue for re-financing.

Mr. Glen Spieth, Chair, opened the public hearing floor for public comment. There was no one in attendance or virtually who wished to speak. Chair, Mr. Spieth, closed the public hearing.

### Lakewood Tree Preservation Code Updates

Ms. Brunell review with board members the process of City Council directing staff to begin the process to amend the City's tree preservation code, in late summer, 2021. Council approved a consulting contract to as well as approved the formation of a Tree Advisory Ad Hoc Committee which was charged with providing recommendations to the Planning Commission and City Council. On May 4<sup>th</sup> the Planning Commission began their review of the committee's recommendations. It is anticipated that the review will continue through June and July, 2022.

Ms. Brunell provided board members with an introduction to the tree preservation code updates including an overview of the existing code, identification of critical issues, ad hoc committee recommendations, and next steps.

Written comments will be accepted through June 30<sup>th</sup>. LHAB members expressed desire to prepare comments to forward to the Planning Commission for consideration during the public hearing scheduled for July 6, 2022.

#### **Nisqually Tribe Outreach**

Board member Mark Hayes has provided two additional contacts for staff to reach out to in order to update the Lakewood Touring Map and website. Staff has reached out to the new contacts, an additional update will be provided at the June 23, 2022 board meeting.

#### **Hopkins House**

The City Council will review the Hopkins House termination request as part of the consent agenda on July 5, 2022

#### Lakewood Touring Map

During the June 6, 2022 City Council Meeting, Councilmember Mike Brandstetter expressed concern that some of the City's significant parks were not included in the potential list of highlighted parks. Parks are not required to be included on the touring map and the board has had several conversations discussing whether or not to incorporate the parks. Councilmember Brandstetter' s concern was that Wards Lake and Springbrook Park were not included on the featured list. The City has planned substantial investments for both of these parks. To revisit the discussion, below is the map and explanation from the April LHAB meeting:

#### **Background:**

The City currently publishes a driving tour map for different residents and Clover Park School District. The map has not been comprehensively updated since 2015.


During the March 24<sup>th</sup> Landmarks and Heritage Advisory Board meeting the board requested that the map be amended to include significant parks in the City.

During the February 22, 2022 joint Parks and Rec Advisory Board and Landmarks and Heritage Advisory Board Meeting the additional change was recommended:

- 1. Update the timeline to include additional Nisqually Tribe historic events
- 2. Add language focused on Nisqually cultural heritage

On March 14, 2022 the City of Lakewood and Nisqually Tribe held a partnership charrette to discuss a variety of upcoming projects at City Parks. During the meeting, staff introduced the touring map to request their involvement. They have provided the City with a contact and are interested in updating the timeline and providing a brief narrative to include as part of the map update.

During the March 24, 2022 Landmarks and Heritage Advisory Board meeting the board voted to move forward with Hiring Jolie Winsett Creative to complete the map update.

The board also requested that the map scale be amended in order to show more of the City including the Chambers Creek Trail & Woodbrook/Tillicum area.

#### April 28, 2022 meeting:

During the board meeting on April 28, 2022 the board stated they'd like to continue to consider the following parks be mentioned or shaded on the touring map: American Lake Park, Chambers Creek Trail, Fort Steilacoom Park, and Harry Todd Park.
