**Call to Order**

Commissioner Bisson called the meeting to order at 9:30 a.m.

**Old Business**

Ms. Pandrea responded to Commissioner Roden's request to address the Sergeant's exam process components and assigned percentages. The exam bulletin which includes an outline of the exam process was provided. The three exam components which are weighted equally at 33 1/3% each comprise an applicant's final score for ranking on the list: the written exam; the work performance ranking; and the oral board interviews. The written exam was developed by Public Safety Testing. Assessors for the oral board include an Assistant Chief, a Lieutenant, and a Sergeant from the cities of Bonney Lake, Olympia and Puyallup.

**New Business**

#### **Examiner's Report**


- Oral board interviews and the work ranking process for Sergeant applicants are next week. An eligibility list will be presented at the July 7 meeting.
