Help **LIGHT** UP Lakewood in the Parade! Businesses, clubs, organizations, and individuals are all invited to light up the holidays walking or with a vehicle in the parade. Show your community spirit! **Blue** lights are recommended, however lights are optional.

- Each entry is encouraged to 'go all out' in decorating their vehicle and wearing festive clothing, making it fun and exciting for participants and spectators alike.
- The Lakewood Parade is both a motorized vehicle parade and walking parade. Trailers and floats are encouraged, but riders must be secured per the rules.
- Businesses, clubs, and organizations can have signage on their vehicle, but lighting and decorations should reflect the Holiday Season.

## PARADE INSTRUCTION SHEET

PARADE DATE: Saturday, December 10, 2022

PARADE BEGINS: 4:30pm

CHECK-IN/ASSEMBLY: 10:00am-3:30pm

Parade ends/tree lighting: 5:30pm City Hall

**CHECK-IN STATION:** All entries must stop at the check-in station located at the entrance to the staging area. There you will receive your parade entry number and any other instructions. Important: To reduce congestion, please appoint one member of your group to check in your entire group.

**STAGING AREA:** The main staging area will be at Colonial Plaza: 6125 Motor Ave, SW, Lakewood, WA 98499.

**JUDGING:** Categories include:

- Most Original
- Most Spirited
- Best Overall Appearance

**RESTROOMS:** Restrooms are located onsite.

**PARADE ROUTE:** Public viewing begins at the intersection of Motor Ave. and Gravelly Lake Drive, it will continue down Gravelly Lake Dr., turn left on Main St, straight to City Hall). Entries may slow down or pause slightly (without stopping) for the cameras and announcement of their entry. See maps at bottom of form.



## Lakewood Parade of Lights Rules

**Keep this Page**

This is a Lakewood community parade. Our goal is to provide a community parade that is safe and enjoyable for both participants and spectators. To that end, we ask the following:

- Parade participants may NOT jump onto or off of any float or moving vehicle.
- *NO STOPPING.*
- You may hand out packaged candy. But please don't throw it or any other items into the crowd. *(This is a risk management requirement.)*
- Riding on the top of or outside of vehicles without belts or harnesses to secure riders is prohibited.
- *SANTA CLAUSE – Only the official parade Santa is allowed, no other vehicles/floats can have a Santa on board*
- The Parade goes rain or cold.
- All motorized vehicles must be operated by a licensed driver, regardless of the vehicle's size or use.
- All vehicle and float operators are required to include proof of current automobile liability insurance for the vehicle being operated. This must accompany your parade application.
- Drivers shall have 180 ° forward vision.
- Exhaust system shall extend beyond any and all decorations so that drivers or riders are not exposed to carbon monoxide fumes. Generator exhaust must be such that it does not pose a hazard to participants.
- Decorative lighting must be UL approved and rated for outdoor use.
- No candles allowed on floats. Fire or open flame on any entrant is prohibited.
- Since safety is a priority, all parade entrants must remain in **forward** motion (no reverse motion) while on the parade route. Entries that stop along the parade route make the parade less enjoyable for the spectators and create problems for entries behind them.
- No excessive speeds, **burn-outs**, tricks, two-wheel driving, or dangerous maneuvers.
- Maintain an interval of 20 **feet** behind the preceding entry.
- Marching entries must keep up with the parade.
- Smoking is prohibited on any float or parade entry
- Alcoholic beverages are prohibited on any float or vehicle or on the person of any participant.
- All entrants must conform to the description stated in their application.
- All Amplification systems must be noted on application.
- Entries depicting violence, drugs, and illegal activities or otherwise deemed inappropriate will not be allowed for this family friendly parade.
- The City of Lakewood reserves the right to bar from the parade at any time any entrant refusing to follow the instructions of the police or parade officials.
- Contact parade officials immediately should you encounter any difficulties. Contact #s will be provided with confirmation and final instructions.
- All entrants must clean up after their entry (animal waste, garbage in staging, horse loading areas, decorations, etc.)

### STAGING AREA:

- Entries will be lined up in order of arrival (with possible adjustments due to music, etc. as determined by Parade Staff.)
- No reverse movement will be allowed within the staging area.
- All entrants must clean up after their entry (garbage in staging, decorations, etc.)
- Vehicles not in the parade will park in the designated area.

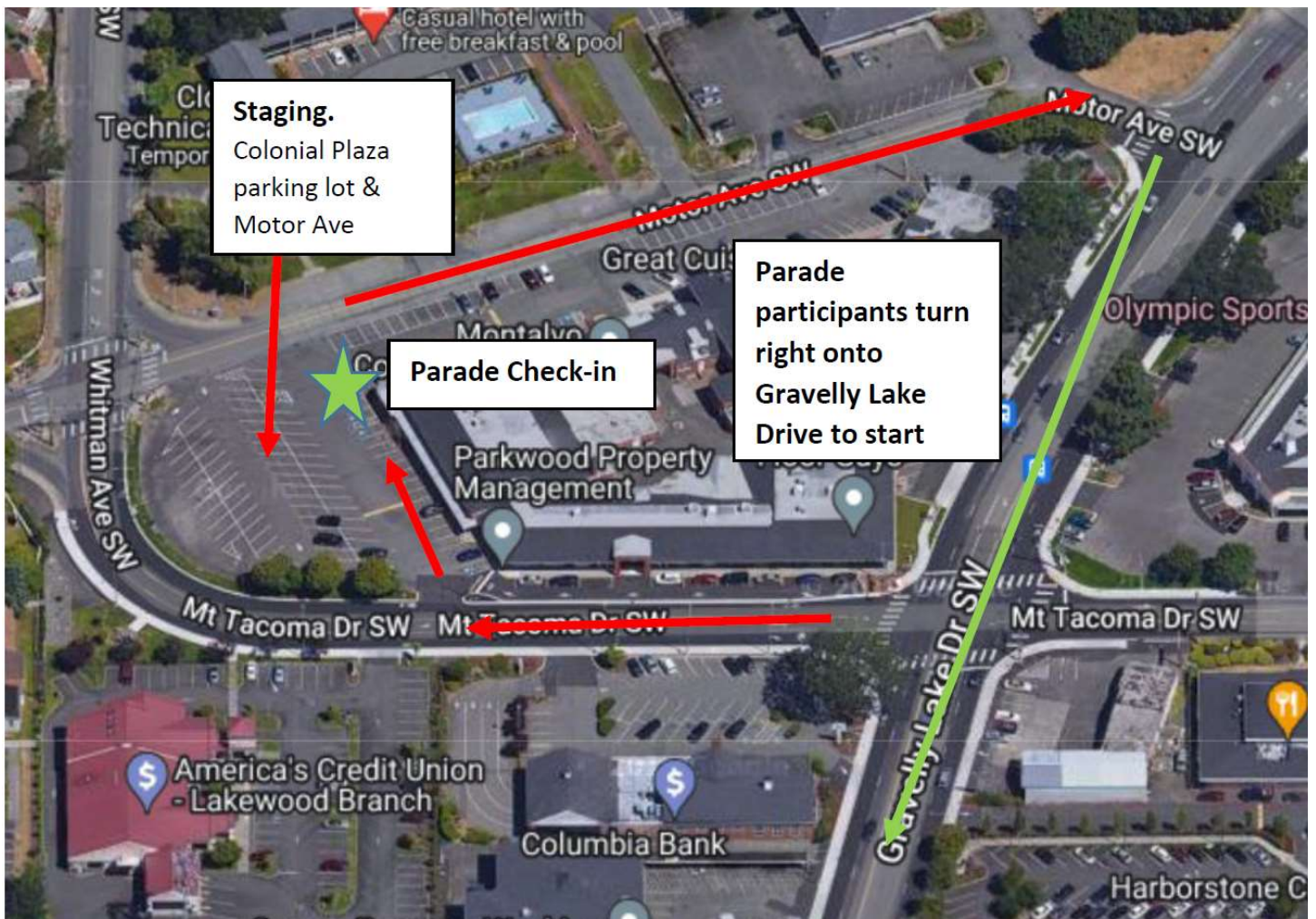

### **Parade Entrant Hold Harmless & Indemnification Release**
