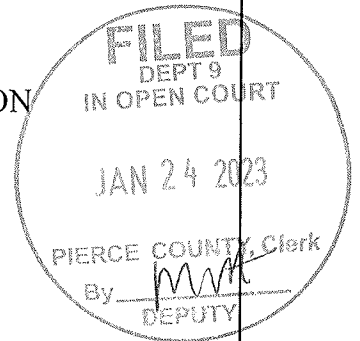

**ORDER TO THE CITY OF
LAKEWOOD ON THE MOTION TO
RESCIND THE JANUARY 11, 2023
ORDER OF THIS COURT**

15 **ORDER**

16 Having considered the briefing and exhibits from the City of Lakewood, along with
17 oral arguments in court presented by counsel for the City of Lakewood, defense counsel
18 for Mr. Allen, and the prosecutor for Pierce County, the Court hereby ORDERS the
19 following:

20 1- The January 11, 2023 order directed solely at the City of Lakewood supersedes
21 the January 9, 2023 order. The January 11, 2023 order states that the City's posts on the
22 City's website and Facebook page "be immediately taken down." The January 11 order
23 remains in place and is not rescinded.

24 2- However, upon hearing argument by the parties, the January 11, 2023 order is
25 modified as follows: The media release from Lakewood Police Chief Mike Zaro dated


1 November 10, 2022, posted to the City's website, shall be redacted by the City of
2 Lakewood to remove any reference to the evidence in the case.

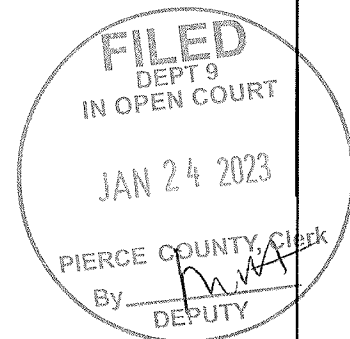
3 3- The Lakewood Police Department Facebook page will remain without redactions
4 because the posting does not refer to the evidence in the case, but refers the user back to
5 the full statement on the City of Lakewood's website, which will be redacted as noted
6 above.




