**ADDENDUM TO INTERLOCAL AGREEMENT BETWEEN THE CITY OF
LAKEWOOD AND THE CITY OF DUPONT FOR MUNICIPAL COURT SERVICES**

WHEREAS, the City of Lakewood ("Lakewood") and City of DuPont ("DuPont") are parties to an Interlocal Agreement for Municipal Court Services (the "Contract");

WHEREAS, the Lakewood City Council and the DuPont City Council appoints a municipal court Judge on a four-year term basis, with the current term length expiring December 31, 2025;

WHEREAS, the current Contract term expires December 31, 2023;


WHEREAS, Lakewood and DuPont are mutually interested in optimizing administrative efficiency by aligning the Contract expiration term with the Judge term length;

NOW THEREFORE, in consideration of the promises set forth herein and the mutual benefits to be derived, Lakewood and DuPont agree to modify Section H. Term. The underlying Contract between the Parties is amended, but only in the following respects:

1. The new expiration date of the current term is now December 31, 2025.





**A RESOLUTION OF THE CITY OF DUPONT, PIERCE COUNTY,
WASHINGTON; AMENDING THE EXPIRATION DATE OF THE
INTERLOCAL AGREEMENT BETWEEN THE CITY AND LAKEWOOD
MUNICIPAL COURT.**

WHEREAS, in 2014 the City of DuPont (City) and the City of Lakewood (Lakewood), pursuant to the State Interlocal Cooperation Act, Chapter 39.34 RCW, entered into an interlocal agreement (Agreement) for Lakewood to provide municipal court, prosecution, public defender and related services to the City; and

WHEREAS, successive iterations of the Agreement have been and continues to be of mutual benefit to both the City and Lakewood; and

WHEREAS, the City and Lakewood appoint a municipal court judge for a four-year term basis, the current term ending on December 31, 2025; and


WHEREAS, the term of the current version of the Agreement expires on December 31, 2023; and

WHEREAS, Lakewood has proposed an addendum to the Agreement to extend its current expiration date to coincide with the end of the municipal court judge term on December 31, 2025, to optimize administrative efficiency for both parties and the City Council concurs;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DUPONT, WASHINGTON DO RESOLVE AS FOLLOWS:

Section 1. The City Council hereby authorizes the Mayor to enter into the attached "Addendum to Interlocal Agreement Between the City of Lakewood and the City of DuPont for Municipal Court Services" (incorporated herein by reference) authorizing the current version of the Agreement to expire on December 31, 2025.
