The Crime Analyst position was filled as of May 1, 2023.

The Sergeants Exam Process update – Six officers applied for the Sergeants promotional opportunity. The written exam is on May 3, 2023.

The Lieutenant's eligibility list expiration date was extended, and three remaining names are on the list.

Entry Level Police Officer Process update- Thirty two applicants applied to test on April 5, 2023, thirteen applicants showed up for the written/PAT, two applicants failed the PAT, and four applicants failed the written. The remaining seven applicants were invited to the oral board on May 15, 2023. PSS is exploring changing the Entry Level Police Officer process because of our low number of candidates. Also, PSS plans to have an officer dedicated to recruiting.

Entry Level Police Officer Eligibility List update – One candidate should have a final offer by next week, four candidates are in the background portion. There are a total of five candidates still on the eligibility list. Lateral Level Police Officer process update – 5 applicants were invited to an oral board on May 12, 2023. There are seven Police Officer positions that need to be filled and ten over hire positions. It was moved and seconded to adjourn the meeting. The motion passed unanimously.
