Call to Order

Chair Gayle Selden called the meeting to order at 9:30 a.m.

Approval of Minutes

New Business

The City Attorney's Response to the disqualification memo question of what documentation does and doesn't come to the Civil Service Board:

The City is subject to three different pieces of State law; Public Records Act, State Retention Laws, and WA State Office of Privacy & Data Protection. In light of this, City Attorney Wachter recommends that the full disqualification reports should not go out in the context of the open meeting or passed out prior to the meeting thru email. Instead, when more information is needed regarding a candidate's disqualification, the Commission could call for an executive session. Additionally, a board member is not responsible for the official documents of the board; the Civil Service secretary is responsible for the documents.

Cancellation of Eligibility

Discussion: Can the commission site a disqualified's name and make a blanket cancellation for the position?

City Attorney Wachter recommends that each disqualification is discussed individually, and a reason should be cited for each disqualification. This mode of operating creates transparency for the public, and it assures the candidate that their disqualification report was reviewed by the commission.

It was moved and seconded to disqualify Robert Carlin from the Entry Level Police Officer eligibility list. *The motion carried unanimously.*
