

RFQ – Military Road widening project; Edgewood to Farwest/112th

Request for Qualifications

City of Lakewood

City of Lakewood (City) is requesting statements of qualifications from firms qualified and interested in providing full survey and civil design services to assist the City with their Military Roadway widening project.

Project Description

The City of Lakewood has received Federal grant funding for the design of the Military Road widening Project.

This project along Military Road from Edgewood to Farwest/112th consisting of curb, gutter, sidewalk, bicycle lanes, associated storm drainage facilities, street lighting, a HAWK signal at one intersection and roadway resurfacing.

This project will include all necessary aspects of topographical survey, traffic and civil engineering services needed to get the project to construction with a full PS&E package.

The project has been assigned a **21%** DBE goal.

The City requests that statements of qualifications include the ability to provide all of the above services. The City reserves the right to negotiate a reduced scope of services with the successful consultant and obtain other consultants for specific project elements.

Qualifications

Qualified consultant teams shall show experience with the following:

1. Experience with projects of similar size and scope.
2. Experience with Federally-funded projects.

3. Experience with WSDOT Highways and Local Programs coordination.

Evaluation Criteria

The statements of qualification will be evaluated based on the following criteria:

1. Project team experience and qualifications including key personnel.
2. Understanding of the project requirements.
3. Project team's experience with topographical survey and right-of-way mapping.
4. Familiarity with WSDOT and FHWA requirements.
5. Approach to project.
6. Past performance and references.
7. Approach to meet DBE goal.

The RFQs will be evaluated by a committee comprised of City staff. The top two (or more) consultants will be invited to interview with the evaluation committee. Interview format will be determined and shared after the RFQ's are reviewed. Final selection for this project will be based on a combination of interview results, RFQ's, and past performance and references.

Qualification Requirements

The City encourages disadvantaged, minority, and women-owned consulting firms to respond.
