ENTRY DEADLINE: Friday, Nov. 22, 2024 at 5 p.m.

EVENT DATE: Saturday, Dec. 7, 2024 from 4:30–5:30 p.m.

WHERE: Parade stages and leaves from Park Lodge Elementary School, 6300 100th Street SW, then travels down Gravelly Lake Drive SW to Main Street SW, and ends just past the roundabout in front of Lakewood City Hall City Hall, 6000 Main Street SW.

WHAT: Help **LIGHT UP** Lakewood by joining the Lakewood Parade of Lights! Businesses, service clubs, organizations, and individuals are invited to join this holiday parade by walking or with a decorated vehicle. Show your community spirit! **Blue** lights are recommended, however lights are optional.

- Each entry is encouraged to 'go all out' in decorating their vehicle and wearing festive clothing, making it fun and exciting for participants and spectators alike.
- The parade is both a motorized vehicle parade and walking parade. Trailers and floats are encouraged, but riders must be secured, per the rules.
- Businesses, clubs, and organizations can have signage on their vehicle, but lighting and decorations should reflect the holiday season.

To be considered for participation, your entry form must be received prior to Friday, Nov. 22, 2024 at 5 p.m. **at Lakewood City Hall, 6000 Main St. SW, or emailed to Sally Martinez:**

PARADE INSTRUCTION SHEET

Date: Saturday, Dec. 7, 2023

Parade start: 4:30 p.m.

Check in/staging: 10 a.m.–3:30 p.m.

Parade ends/tree lighting: 5:30pm City Hall

CHECK IN STATION: All entries must stop at the check in station located at the entrance to the staging area. There you will receive your parade entry number and any other instructions. **Important:** To reduce congestion, please appoint one member of your group to check in your entire group.

STAGING AREA: The main staging area is at Park Lodge Elementary School, 6300 100th Street SW.

JUDGING: Parade entries are eligible for award recognition by judges. Categories include:

- Most Original
- Most Spirited
- Best Overall Appearance

RESTROOMS: On site.

PARADE ROUTE: Public viewing begins at the intersection of Alfaretta and Gravelly Lake Drive. The parade continues down Gravelly Lake Drive, turns left onto Main Street, and goes straight to Lakewood City Hall, ending just behind the roundabout in front of City Hall. Entries may slow down or pause slightly **(without stopping)** for the cameras and announcement of their entry. See maps at bottom of form.

Lakewood Parade of Lights Rules

Keep this Page

This is a City of Lakewood community parade. Our goal is to provide an event that is safe and enjoyable for participants and spectators. To that end, we ask the following:

- Parade participants may NOT jump onto or off of any float or moving vehicle.
- NO STOPPING.
- You may hand out packaged candy. But please don't throw it or any other items into the crowd. *(This is a safety requirement.)*
- Riding on the top of or outside of vehicles without belts or harnesses to secure riders is prohibited.
- **SANTA CLAUS:** Only the official parade Santa is allowed, no other vehicles/floats can have a Santa on board.
- The Parade is held regardless of inclement weather, please dress appropriately.
- All motorized vehicles must be operated by a licensed driver, regardless of the vehicle's size or use.
- All vehicle and float operators are required to include proof of current automobile liability insurance for the vehicle being operated. This must accompany your parade application.
- Drivers shall have 180 ° forward vision.
- Exhaust system shall extend beyond any and all decorations so that drivers or riders are not exposed to carbon monoxide fumes. Generator exhaust must be such that it does not pose a hazard to participants.
- Decorative lighting must be UL approved and rated for outdoor use.
- No candles allowed on floats. Fire or open flame on any entry is prohibited.
- All parade entries must remain in **forward** motion (no reverse motion) while on the parade route. Entries that stop along the parade route make the parade less enjoyable for the spectators and create problems for those behind them.
- No excessive speeds, burn-outs, tricks, two-wheel driving, or dangerous maneuvers.
- Maintain an interval of 20 feet behind the preceding entry.
- Marching entries must keep up with the parade.
- Smoking is prohibited on any float or parade entry.
- Alcoholic beverages are prohibited on any float or vehicle or on the person of any participant.
- All entrants must conform to the description stated in their application.
- All amplification systems must be noted on application.
- Entries depicting violence, drugs, and illegal activities or other materials deemed inappropriate will not be allowed in this family-friendly parade.
- All entrants must clean up after their entry (animal waste, garbage in staging, horse loading areas, decorations, etc.)

Lakewood Parade of Lights Rules (continued)

Keep this Page

The City of Lakewood reserves the right to bar from the parade at any time any entrant refusing to follow the instructions of parade officials or police. Contact parade officials immediately should you encounter any difficulties. Contact information will be provided with confirmation and final instructions.

Staging area rules:

- Entries will line up in order of arrival (with possible adjustments due to music, etc., as determined by parade staff.)
- No reverse movement will be allowed within the staging area.
- All entrants must clean up after their entry (garbage in staging, decorations, etc.)
- Vehicles not in the parade must park in the designated area.

Parade Entrant Hold Harmless & Indemnification Release

We understand that this is difficult to get all of the members of your group to sign the release waivers. This is required for participation. This year we have two options.

There is Parade Entrant Hold Harmless & Indemnification Release that you are to bring with you the day of the event.

As the members of your group arrive you will have the individual (if over 18) print their name and sign.

If the participant is under 18, their parent or guardian will need to print their name, their child's name, and sign.

If you have more than 20 participants in your group, please make additional copies of the sign in sheet.

If for a parent or guardian will not be dropping the child off they can sign the "day of" waiver in advance or they may fill out individual waiver (last page).
