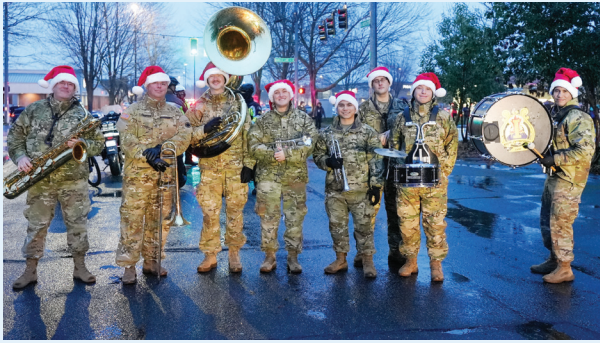

# Reflecting on a year of accomplishment

**A**s we close out 2024, we are proud of the many accomplishments we achieved this year. While the list is too long for the limited space we have here, below are some of the substantial strides we made in enhancing infrastructure across the city, our continued support for public safety and our commitment to overall community well-being.

We started 2024 with an ambitious plan to improve roads and increase pedestrian safety across the city. The result is the completion of eight projects that invested \$12.46 million in our community. That investment upgraded and maintained key thoroughfares across the city.

This included improvements to:

- 84th & Pine
- Ardmore/Whitman/93rd
- Hipkins Road
- Farwest Drive
- Interlaaken Drive bridge repair
- 2024 road patching
- 2024 chip seal
- 2022 Street Light Program

We also completed projects on Union Avenue and 112th Street between Gravelly Lake Drive and Highland, which started in 2023.

These improvements ensure smoother and safer travel for our residents and continue safe pedestrian connections across the city. The road and sidewalk improvements not only enhance transportation but also boost economic vibrancy by connecting neighborhoods and supporting local businesses.

This year we also saw crime trends drop significantly. The continued decline is attributed to multiple factors, including the installation of a Flock video system by the Lakewood Police Department. These high-tech cameras scan license plates at major intersections, instantly identifying vehicles reported as stolen. In 2024 we saw vehicle theft decrease by an impressive 68% by the third quarter, compared to the same period in 2023. This marks a major achievement in

the city's crime prevention efforts and reinforces Lakewood as a safe place to live and work.

We continued to prioritize community resilience with our commitment of American Rescue Plan Act monies to critical local programs. We awarded more than \$13 million to support housing stability initiatives, food security, and youth programming to address current needs and provide long-term benefits. Small businesses received targeted assistance, strengthening Lakewood's economic foundation, while money was committed to improvements at some of our parks to enhance recreation options and contribute to residents' quality of life.

Each of these accomplishments highlights the City Council's commitment to making Lakewood a safer, stronger and more vibrant community for all.

Continued public safety investments remain paramount in 2025.

Other initiatives for 2025 include continued focus on enhancing connectivity and safety on our roads, and increasing recreation opportunities through a range of initiatives. With a \$1 million federal RAISE grant, we will develop a plan that sets the path to explore building a multigenerational community center and park in our commercial downtown district.

We will continue road improvements, connecting neighborhoods and ensuring safer pedestrian routes citywide. We'll also see the completion of park capital projects, including major upgrades at Wards Lake and American Lake parks.

And we'll increase public access to our lakes with enhancements to Edgewater Park and the development of a street-end pilot project to transform overgrown public right-of-way into access to Lake Steilacoom.



# Lakewood parks under construction

**F**rom major improvements to replacing aging park signage, there's a lot going on in Lakewood parks. Here's a list of just some of what's happening — or coming up.

• **American Lake Park:** Construction is underway on this \$4.2 million project that will make significant upgrades to the 5-acre waterfront park. Construction is anticipated to be complete in 2025.

• **Fort Steilacoom Park:** There are multiple projects planned. They include:

• **Nisqually Indian Tribe Partnership Project.** Construction is expected in 2025 with completion by fall 2025.

• **ADA and overflow parking.** Design is expected to begin in early 2025 with permitting to follow by second quarter 2025.

• **Wards Lake Park improvements:** Construction is anticipated to occur early in 2025 and continue until fall 2025.

• **Oakbrook Park improvements:** A new park shelter and pedestrian perimeter pathway are expected to be installed by early spring 2025.

• **Primely Park improvements:** Construction of the playground and ADA access are expected to be finished by spring 2025.



Construction began this fall on American Lake Park. Work includes improving access to the waterfront, replacing the retaining wall and bulkhead, and adding a new restroom and shelter.

• **Harry Todd Park pickleball courts:** Construction will begin in 2025 and is expected to be complete by summer 2025.

• **Harry Todd Park deferred maintenance grant improvements:** Construction to begin in 2025 and is expected to be complete by summer 2025.

• **Park sign replacement:** The city is replacing the aging signs at all its parks. Work will begin in 2025 and is expected to be completed by summer 2025.

• **Electronic message board:** A new sign will be installed in

2025 on Gravelly Lake Drive near the Colonial Plaza.

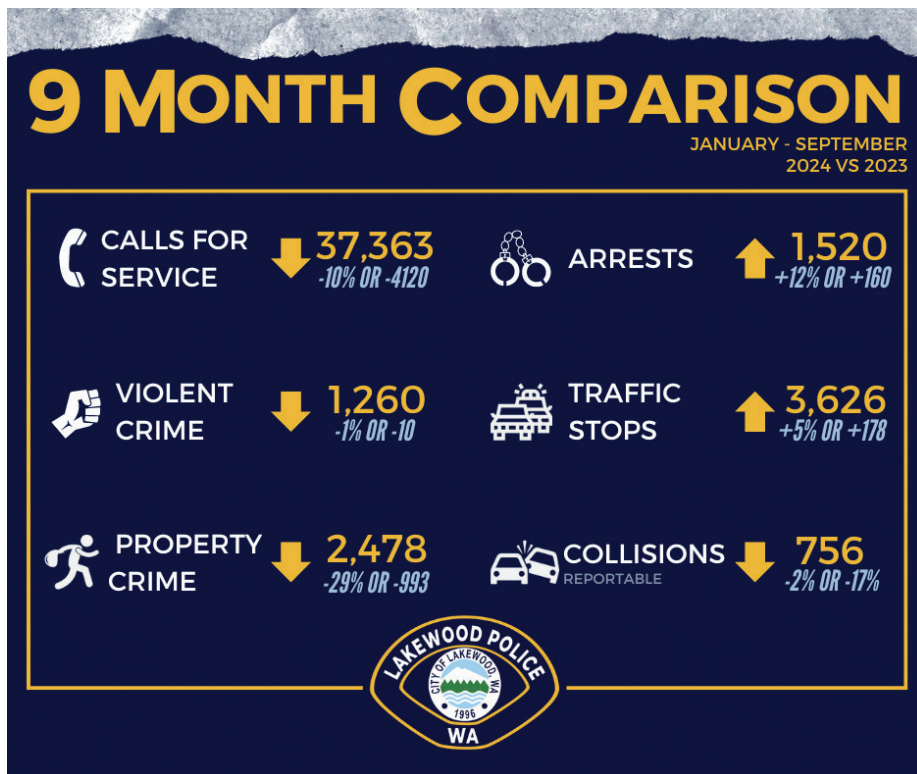

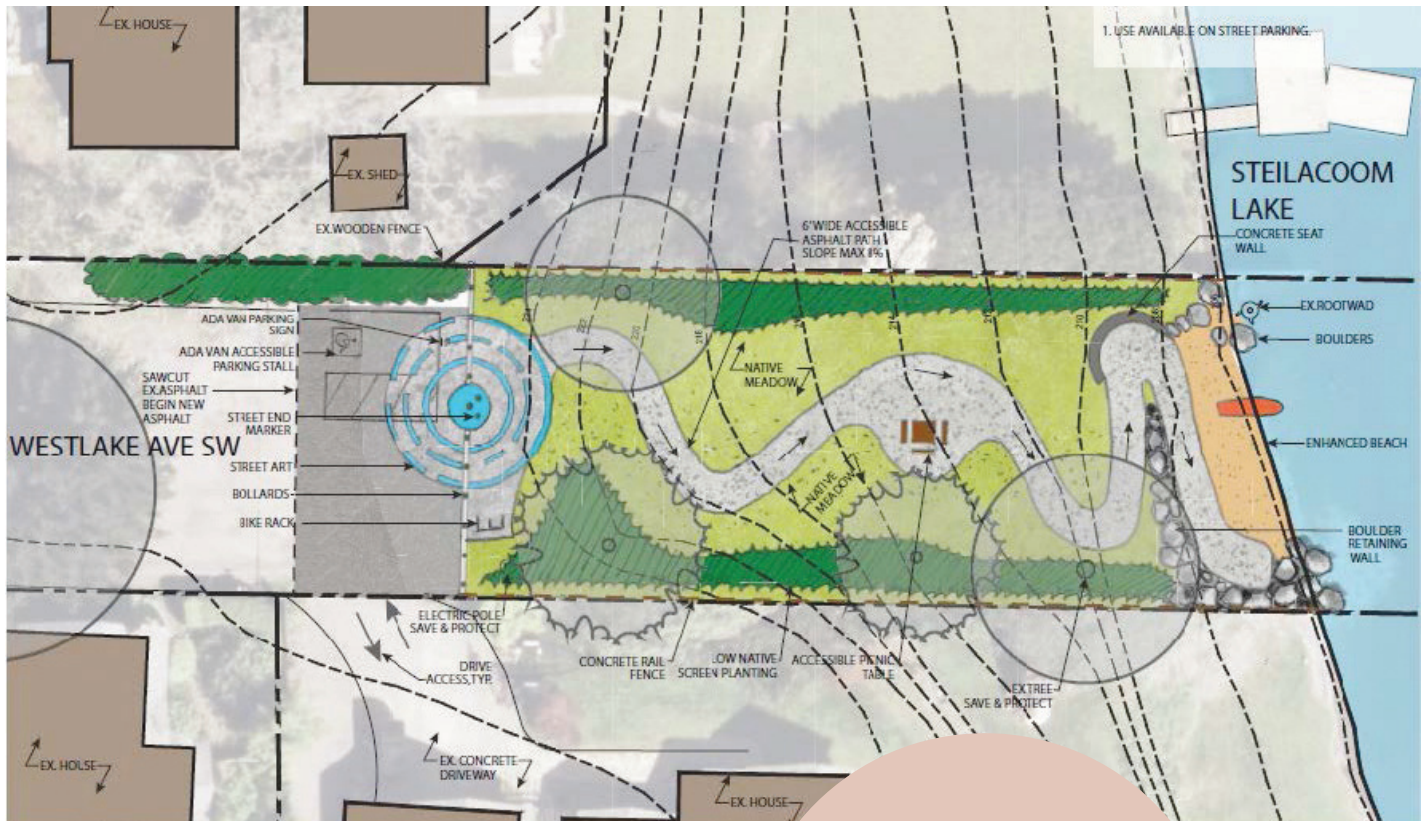

# Developing Lakewood's street ends

**I**n September the Lakewood City Council directed the city to move forward with a pilot project to improve public access to Lake Steilacoom by developing a “street end” at Westlake Avenue SW.

This came after discussion and review of recommendations from the city’s Parks and Recreation Advisory Board. The advisory board made

its recommendation after reviewing a 2022 updated street end report and developing assessment criteria of the city’s primary street end properties. Criteria included:

- Safety and security (considering natural site surveillance)
- Equity (based on area median income and neighborhood health data)
- Other existing access to lakes
- Water quality of the lakes

- Linear feet of shoreline at each site
- Access to fishing (a highly requested activity)
- Will improvements provide a significant change of use?

The advisory board ultimately selected Westlake Avenue as the first site to develop. This street was chosen because it had no apparent encroachment issues with neighboring properties, there is good natural site surveillance, and the



surrounding community currently uses the site. Also, there is less public access to Lake Steilacoom than other lakes in the city.

The advisory board also discussed the limited public access to Gravelly Lake. It determined a successful pilot project on Lake Steilacoom would demonstrate how a street end can be an asset to the city. By creating positive

community use and support, public trust will be increased for future sites like Gravelly Lake.

Design and community engagement is expected to begin later in 2025 on the Westlake pilot project. The community will be invited to help develop the final design and be involved. Construction is anticipated to begin in 2026.

## Can I clear a street end in Lakewood?

Not without permits. Most work in the city's rights-of-way require permit approval before anything can be done.

Why? Despite the good intentions of volunteers who want to help, there can be unintended consequences or impacts that the public is not aware of.

After a public right-of-way on 100th Street SW was cleared of vegetation this summer by volunteers, the city received inquiries about how to do this on other street ends.

Street ends are parcels that date back to before incorporation. They are where the road dead ends into a body of water.

The work to clear the vegetation at 100th Street was done without city approval or permits. The City had to respond to the cleared area at 100th Street and do additional work to address stormwater run-off and other impacts that were the result of the vegetation removal.

Because street ends abut the shoreline, there are often additional considerations that must be reviewed based on the city's critical areas ordinance and stormwater and shoreline master program regulations.

# Construction Alert: Steilacoom Boulevard

**I**n November the Lakewood City Council approved a contract with Active Construction Inc. to complete road improvements to Steilacoom Boulevard SW between Weller Road SW and 87th Avenue SW.

The total project is estimated at about \$6 million. The city applied for and received more than \$5 million in grant funding for the construction portion of the project.

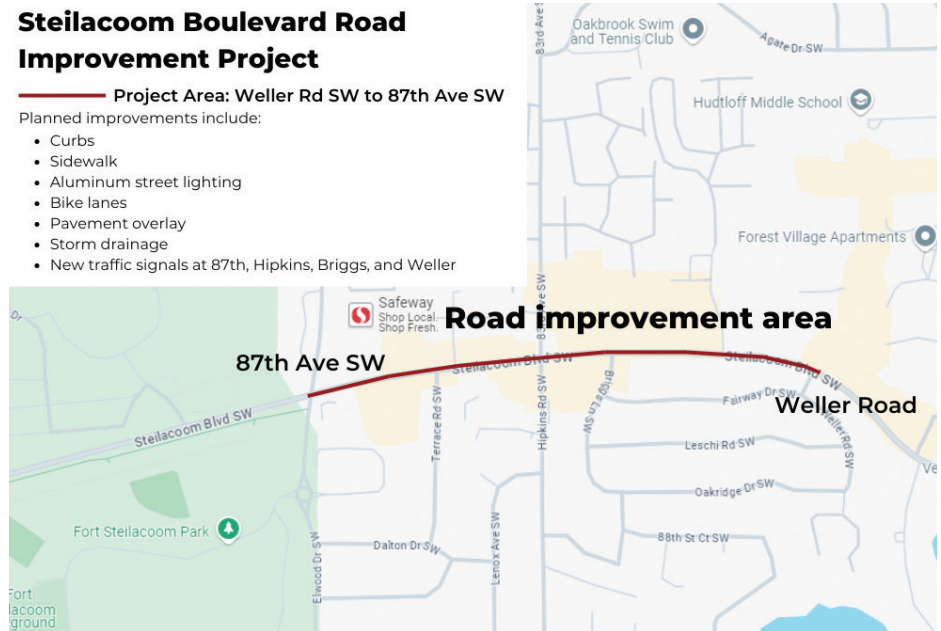
Improvements include adding curbs, sidewalk, aluminum street lighting and bike lanes to Steilacoom Boulevard. Storm drainage will be replaced, and new traffic signals will go in at 87th Avenue SW, Hipkins Road SW, Briggs Road SW and Weller Road SW. The pavement will be overlaid and the road restriped with durable markings.

## Steilacoom Boulevard Road Improvement Project

Project Area: Weller Rd SW to 87th Ave SW

Planned improvements include:

- Curbs
- Sidewalk
- Aluminum street lighting
- Bike lanes
- Pavement overlay
- Storm drainage
- New traffic signals at 87th, Hipkins, Briggs, and Weller



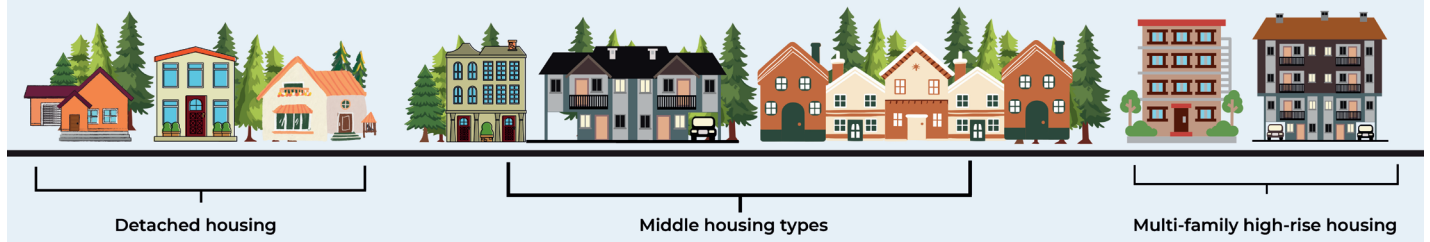
**This winter construction will begin on Steilacoom Boulevard between Weller Road and 87th Ave SW. The road will remain open during construction but lanes will be reduced and drivers should expect traffic backups.**

Construction is anticipated to start this winter. A construction schedule will be shared once it is finalized with the contractor.

During construction the road will remain open, but lanes

will be reduced. Drivers should expect backups, especially during morning and afternoon commute hours. Plan accordingly and use alternate routes where possible.

## New housing laws take effect in 2025

Beginning Jan. 1, 2025, new housing regulations will take effect across Lakewood. These state-mandated regulations are aimed at increasing housing opportunities, including “middle” housing, which will help meet housing targets to provide more places for people to live in Lakewood.

Under the new state regulations people can build up to two (or up to four if within ¼ mile of a “major transit stop”) attached or detached accessory dwelling units (ADUs) on single-family lots. In some cases, they will be able to build duplexes, triplexes and up to sixplexes, small

courtyard apartments and cottage housing on historically single-family lots.

These new regulations are the result of state law changes aimed at creating more affordable housing options across the state. To learn more about adding an ADU or developing your property, call the Planning and Public Works Department at 253-512-2261.

# Burs Restaurant

For nearly 70 years, the welcoming staff at Burs Restaurant has served comfort food to Lakewood residents in the morning and provided a space to meet with friends after work at night. Ownership of the restaurant has changed twice since its founding in the 1950s, but the spirit of the restaurant and many of the staff have remained the same.

Chris Judd, southern regional director for Burs current owner, Sound Restaurant Family, said that's what makes him the proudest: The staff that keep the beloved restaurant running.

"You can't teach people to care about where they work," Judd said. "The people who live in

this area and also work here care deeply about it."

On top of the longtime employees, Judd credited the restaurant's regulars with keeping the diner bustling for a generation. Every morning around 7 a.m. the restaurant is full of diners who have eaten breakfast at Burs for years. Now, a new generation of young Lakewood families is adopting the restaurant as their go-to, Judd said.

Burs is a Lakewood dining icon. It is part of Lakewood's history and heritage.

For its reputation of great food, its sense of community, its outstanding service and its years as an established



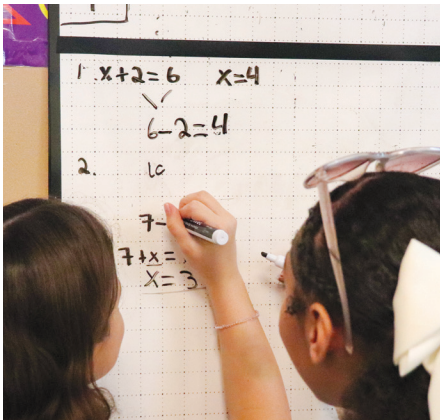

TRANSFORMING MATH IN CLOVER PARK SCHOOL DISTRICT

Clover Park School District (CPSD) is implementing innovative changes to strengthen students' foundational math skills and expand opportunities in secondary math.

CPSD adopted the Cognitively Guided Instruction (CGI) framework at the elementary level, allowing students to approach math in a way that makes sense to them. This method encourages critical thinking and deeper understanding.

In middle school, CPSD is introducing Building Thinking Classrooms, a strategy that encourages collaborative problem-solving. Students work in groups to tackle increasingly complex math challenges, enhancing their math comprehension and teamwork skills.

CPSD is accelerating the math curriculum so that middle school students can complete four years of math in three. Starting next year, all eighth graders will take Applied Algebra 1, preparing them for

Algebra 2 in 10th grade. This track puts students on track for Calculus by 12th grade and offers opportunities for students to earn college credit or participate in the Running Start program.

CPSD started the middle school math curriculum acceleration in sixth grade which resulted in a three-point percentage increase in the Smarter Balanced Assessment (SBA) results from the previous year and a three-point percentile growth in student achievement. The district expects to continue this trend of steady growth as we accelerate more math courses each year.
