Review 2024 Contract Performance

Shannon updated the group on the 2024 contract performances. All service providers participated in successful mid-year motoring's and all but two service providers met their annual goals. Due to experiencing a pipe burst, LASA was unable to open the hygiene station in 2024 and Rebuilding Together South Sound completed only seven of eight home rehabilitation projects due to construction on the eighth project taking longer than anticipated.

Members agreed changes are necessary to the next funding rounds application and rating tool to allow for a more equitable distribution of funds and unified rating system. Meetings in 2025 and 2026 will be dedicated to this task.
